In line with the Department's objective to bring the National Greening Program (NGP) closer to the public and other stakeholders, the NGP Coordinating Office (NGPCO) proposes to strengthen its social media presence and Information, Education, and Communication (IEC) campaigns through the production of audio-visual presentations (AVPs) on the success stories of certain NGP plantation sites in the country.

This year, we intend to produce three (3) video packages, each comprised of three (3) sites that will entail guided interviews, photos, and video shoots which we selected as regions IV-B, V or VI, and IX respectively.

The three (3) selected best sites per region must have a captivating history that will showcase the importance and emerging impacts of NGP as well as the experiences, good practices, and lessons in the lives of the locals in terms of its economic and ecological value.

Once the Regional Offices have pre-selected the sites, a team from FMB will also conduct an interview with the People's Organization (PO) President and at least three (3) locals per site for their testimonials.

We request your office to please extend necessary assistance to the team that will be deployed, including coordination with the POs that will be visited, and we will firm up with you the schedule of the activity in your respective regions.
