This is to provide a status on the discussion of the Department of Environment and Natural Resources (DENR) - National Commission on Indigenous Peoples (NCIP) on the **Subgroup on FPIC, Tenurial Instruments and other DENR permits, and Enforcement** which is being co-chaired by Engr. Caridad Katherine Gullunan from the NCIP. The objectives of this Subgroup are as follows:

- To provide for enforcement measures and mechanisms as regards:
 - o the issuance of cease-and-desist orders (CDO) by NCIP and/or DENR;
 - the cancellation of permits, licenses, instruments, or certifications, in cases of violation of the IPRA, Memorandum of Agreement, and other pertinent laws, rules and regulations; and
 - utilization, control and enjoyment by the ICCs/IPs of the land and natural resources within their ADs/ALs in light of the expiration of programs, permits, licenses, and other RUIs issued thereon.
- To ensure that FPIC from the ICCs/IPs and the corresponding Certification Precondition (CP) are secured before any person, organization, or entity, public or private, conducts any project, program or activity, including issuance or renewal of

permits and licenses and the conversion or merging of tenurial instruments, within or affecting ADs/ALs;

• To provide for the formal recognition of sustainable traditional resource use of ICCs/IPs within their ADs/ALs, including the formulation of a streamlined process for approval of development of projects initiated by ICCs/IPs within their ADs/Als.

Be informed that this subgroup conducted its second meeting last 14 March 2023, attended by representatives from NCIP, DENR field offices, LMB and FMB and discussed the updates of the agreements during the first meeting. The summary of the discussion and agreements is attached as Annex of this Memorandum. As a way forward, the next subgroup meeting is scheduled on April 20, 2023 with the following agenda:

- NCIP Presentation of the MOA and Enhanced FPIC process
- Forging partnerships and collaboration: the experience of DENR Region 1 and Region 10

SUBGROUP ON FPIC. TENURE INSTRUMENTS AND ENFORCEMENT

This is in reference to the Department of Environment and Natural Resources (DENR) - National Commission on Indigenous Peoples (NCIP) high-level policy discussions of issues and concerns over forest lands, alienable and disposable public lands, mineral resources, and other natural resources with issued ancestral lands, domains and those with ongoing claims. On 17 August 2022, a follow-up meeting was conducted which was presided by Joselin Marcus E. Fragada, CESO III, Undersecretary for Field Operations-Mindanao together with Commissioner Rhodex P. Valenciano as the designated/nominated focal persons of their respective offices in the June 22, 2022 meeting.

During the said meeting, it was agreed that the creation of different subgroups be formalized in order to facilitate discussions on key issues, to wit:

- a) Subgroup on Titling of Lands and Section 56 on Vested Rights
- b) Subgroup on Mapping and Data Sharing
- c) Subgroup on Coordination Mechanism for Section 58 of IPRA
- d) Subgroup on FPIC, Tenurial Instruments and other DENR permits, and Enforcement
- e) Subgroup on Dispute Resolution

The Forest Management Bureau was assigned to lead discussions on <u>Subgroup on FPIC, Tenurial Instruments and other DENR permits, and Enforcement which is being Co-Chaired by Engr. Caridad Katherine Gullunan of NCIP with the following objective(s):</u>

- To provide for enforcement measures and mechanisms as regards:
 - o the issuance of cease-and-desist orders (CDO) by NCIP and/or DENR;
 - the cancellation of permits, licenses, instruments, or certifications, in cases of violation of the IPRA, Memorandum of Agreement, and other pertinent laws, rules and regulations; and
 - utilization, control and enjoyment by the ICCs/IPs of the land and natural resources within their ADs/ALs in light of the expiration of programs, permits, licenses, and other RUIs issued thereon.
- To ensure that FPIC from the ICCs/IPs and the corresponding Certification Precondition (CP) are secured before any person, organization, or entity, public or private, conducts any project, program or activity, including issuance or renewal of permits and licenses and the conversion or merging of tenurial instruments, within or affecting ADs/ALs;
- To harmonize overlapping jurisdictions between DENR and NCIP as regards reservations, such as forest reservations, mineral reservations, and watersheds, which are located within ADs/ALs but are also covered by Presidential Proclamations or laws; and [This was suggested to be dropped in the discussion of this subgroup since this is the main concern of the Subgroup on Coordination Mechanism for Section 58 of IPRA]
- To provide for the formal recognition of sustainable traditional resource use of ICCs/IPs within their ADs/ALs, including the formulation of a streamlined process for approval of development of projects initiated by ICCs/IPs within their ADs/Als.

Please be informed that an initial meeting/discussion was conducted last 12 October 2022 (see Annexes for detailed discussion) and agreed to limit the scope for each topic, to wit:

 NCIP to discuss and present their proposed level of participation on DENR activities especially on the processes of issuance of CDO and other administrative process;

- 2. NCIP to provide access to the existing IPO registry and other similar databases relevant to tenure/permit issuances;
- NCIP to provide a directory/database of NCIP officials/staff/indigenous peoples
 organizations representatives to assist the forest tenure instrument applicants on the
 FPIC process;
- DENR to submit the list of activities programs and permits being processed and it mainstreams/integrates IP/ICC culture and NCIP processes;
- 5. DENR to submit draft MOA to NCIP for review and comments; and
- 6. NCIP and DENR to provide a clear stand if indigenous peoples should be required to secure utilization permits of natural resources within their ancestral lands/domains.

In this regard, the regional offices were instructed to submit the following information being monitored/ processed/supervised which in any way affects/involves IPs/ICCs within your sector/office:

- 1. List of programs, permits, licenses, and clearances
 - processes, requirements and timelines
- 2. Survey process for permits and licenses that require spatial verification
- 3. Responsibilities and rights of permittees/holders
- 4. Possible convergence and collaboration

Hereby are inputs from field offices in a matrix with specific cases attached in the *Annexes*:

- 1. NCIP clearances be required only on areas with approved CADC/CADT;
- CBFMA, SIFMA, IFMA, FLGMA, FLAg, FLAgT, and ISF within recognized Ancestral Domain/Land to undergo FPIC Process with the required two (2) meetings only (Not a full blown FPIC) per Section 24 of the Revised Guidelines of FPIC with executed MOA;
- Defining the metes and bounds between timberland and CADT through provision of certification from DENR on recognized ancestral domains including claim and crosschecking of available data such as referring to list of ancestral domain with map, conduct of joint (NCIP and DENR) resurvey and re evaluation of expired CSC;
- 4. Eradicating illegal activities within timberland through joint enforcement of ENR laws and IEC campaign; and
- Possible creation of localized JAO consistent with JAO 2012-01 considering the withdrawal of NCIP from the JAO per NCIP En Banc Resolution No. 08-03, 2019 re Resolution withdrawing the NCIP's approval on the Joint DAR-DENR-NCIP-LRA (JAO No. 01-12) and membership to the joint National Committee created pursuant thereto".

Recently, the Free and Prior Informed Consent (FPIC) application for the activity on the relocation of the perimeter boundary coordinates of Camp Kibaritan (PP 134, dated July 11, 1963) is still at the Office of the NCIP Region 10 and the allocated funds are facing possible lapse if not accomplished the soonest. The survey has no adverse effects on the environment since it only relocates the presidential proclamation's technical description on the ground.

Also, several Community-Based Forest Management Agreements (CBFMAs) and holders of other Tenurial Instruments (IFMA, SIFMA, FLGMA/FLGLA) recommended for renewal based on the results of the conducted performance evaluation were having difficulty in the tedious process of securing the FPIC. Perhaps, due to the conflicting issuances in Region X. These include overlaps between the tenurial instruments of the DENR and NCIP, the NCIP with DAR, the DAR with that of Military Reservations.

Approximately 12 thousand hectares of the areas with conflict issuances between the DENR and the DAR while a total of 92 thousand hectares with conflict issuances between the DENR and the NCIP. Per record of this office, Bukidnon has the most number of polygons and largest area with conflict issuances of 109 thousand hectares, followed by Misamis Oriental at 50 thousand hectares. As of August 2022, this office still have around 728 hectares of data that needs to be validated (copy attached).

Region 12

Land conflict affects current implementation and monitoring of the flagship program of DENR, the National Greening Program. The following are the issues, concern and clarifications that DENR and NCIP must address with a concrete solution, to wit;

- a. What should be our legal and appropriate action if claimed CADT is not registered in the Register of Deeds (ROD) versus those registered?
- Renewal of Certificate of Stewardship Contract that are already developed and covered with existing programs of DENR like National Greening Program.

Our partner in the upland must not sense prejudicing on their behalf since they had already implemented the program from the start and developed it in accordance with the terms and conditions of the stipulated contract.
