1st FIELD OPERATIONS MANAGEMENT CONFERENCE April 16-18, 2023 Clark, Pampanga

- 1. The DENR will be conducting its 1st Field Operations Management Conference at Clark Marriott Hotel Clark Field, Pampanga.
- 2. Attendance at the conference is strictly limited to the USECs, ASECs, Bureaus/Service Directors, REDs, RDs, Assistant Regional Directors and Regional Planning Officers.
- 3. The conference will be live streamed via zoom at 8:30 AM on April 17 and 18, 2023. All PENROs, CENROs and Regional Division Chiefs and PENRO Division Chiefs are enjoined to participate on these days. One (1) official account per office shall be allowed to join the virtual conference. The ZOOM link will be provided during the opening program.
- 4. All DENR officials and participants are required to wear business attire and ARTA ID during the two-day event.
- 5. Participants traveling by air at the Clark International Airport will be picked-up by the assigned vehicles. Meanwhile, participants traveling from NAIA Terminal 2 and 3 can take point-to-point (P2P) buses to Clark. See attached P2P schedule.

- 7. For those who will be arriving on April 16, 2023 (Day 0), check-in time is 4:00 PM. Dinner will be served until 10:00 PM at the Marriott Hotel.
