In compliance with the mandate of this Bureau to provide technical guidance to the central and field offices and recommend policies programs towards the achievement of sustainable forest management, may we inform you that we will be conducting a technical monitoring, evaluation, validation and data gathering on the issued Certificate of Registration as Log/Lumber Dealer (CRLD) Permits by the DENR Regional Offices through the Forest Resource Management Division (FRMD) of FMB. The activity shall assess the implementation of FAO No. 26 dated May 21, 1956 by the DENR Regional Offices and evaluate the relevance of the provisions of the said guidelines considering that the same was signed in 1956.

Relative thereto, may we request your assistance in providing the updated list of holders of Certificate of Registration as Logs, Lumber and Commercial Piles Dealer Permits within your jurisdiction together with corresponding monitoring reports, using the attached template which will serve as basis in the technical monitoring and evaluation.
