**GREETINGS!**

This is in reference to the *KAPASYAHAN BLG. 65-2023* dated 21 March 2023 issued by your Honorable Office requesting the deferment of the execution of the **TREE CUTTING PERMIT NO. DENR-CENRO-SOCORRO-2023-001**.

The undersigned recognizes the predicament and sentiments of all the members of the *Sangguniang Bayan* as a collective body. However, it is the paramount interest of the undersigned to protect the lives of its constituents which is among the fundamental rights enunciated in the 1987 Philippine Constitution.

In order to promote the protection of the right to life, the undersigned, as the duly authorized representative of the Local Government of Baco applied for a permit to cut trees with the Department of Environment and Natural Resources through the Community Environment and Natural Resources Office (CENRO) Socorro. Pursuant to such application, the inspector from the CENRO Socorro conducted an ocular inspection of the trees subject of the application. After a careful inspection conducted by the CENRO representative, it was found out that the trees pose danger to the lives and property in public places, hence, a permit was issued granting the application.

Needless to say, the DENR is the lead agency in implementing environmental laws. Pursuant to the pertinent laws, rules, and regulations, the DENR CENRO has the authority to issue permits to cut trees after conducting an inspection. By issuing a permit, it presupposes that they have inspected the

area, and a finding was concluded that there is indeed a need to cut the trees subject of the application. Hence, the subject permit is presumed to have been issued with regularity in the performance of official duty.

Relative thereto, the undersigned is constrained not to grant the request of the *Sangguniang Bayan* to defer the implementation of the permit unless a restraining order or recall of the permit is issued by the agency concerned.

Your kind consideration on the matter is highly appreciated.

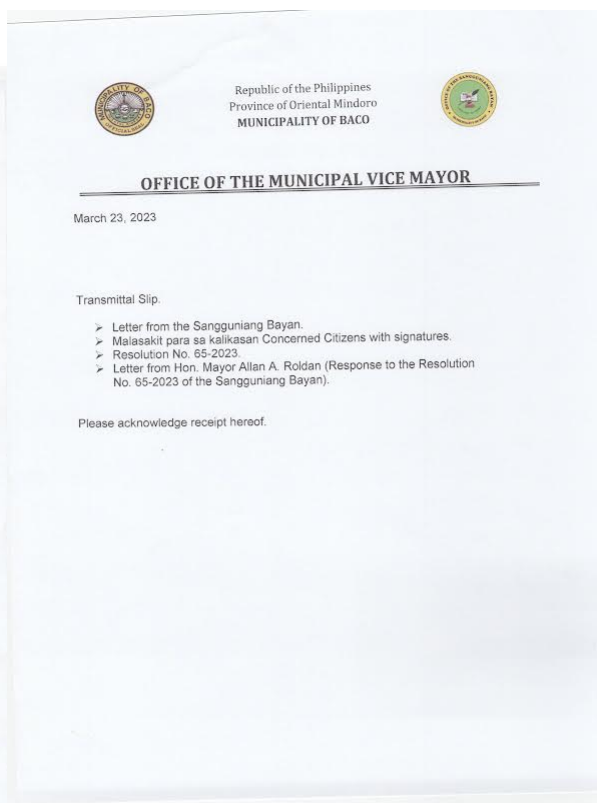
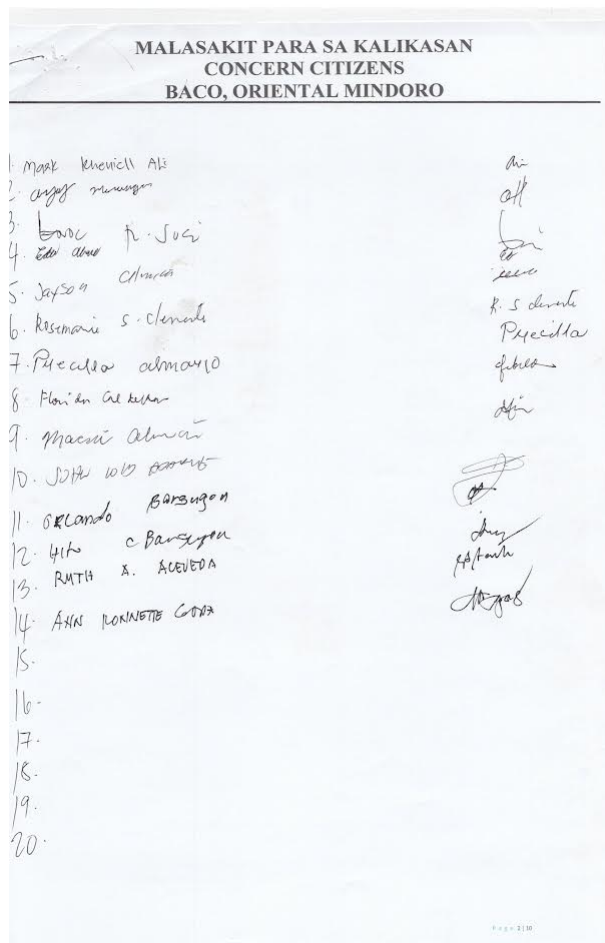
