TERMS AND CONDITIONS

- 1. This permit is issued for the permittee to operate One (1) unit 250.0 kVA Caterpillar Diesel-fired generator set at the permittee's establishment.
- Must conform to National Emission Standards for Source Specific Air Pollutants (Section 1, Rule XXV, Part VII of RA 8749) and Source Specific Ambient Air Quality Standards (Section 1, Rule XXVI, Part VII of RA 8749).
- 3. Must submit notarized Quarterly Self-Monitoring Report (SMR) based on DAO-27, Series of 2003 on or before the filing dates:

1st Quarter SMR (January to March)
2nd Quarter SMR (April to June)
3rd Quarter SMR (July to September)
4th Quarter SMR (October to December)

15th Day of April15th Day of July15th Day of October15th Day of January

- 4. Upon due notice and hearing, if the Permittee is found to be non-compliant with any of the above mentioned Permit conditions and/or the provisions of R.A. 8749 including its implementing rules and regulations, shall be a ground for this Office to suspend/revoke the Permit issued.
- 5. Subject to revocation if found violating the said permit conditions and other provisions of the Philippine Clean Air Act of 1999 (RA 8749) and its Implementing Rules and Regulations.

This operating Permit shall be posted in a conspicuous location near the equipment and shall be adequately framed or otherwise protected against damage. Application for the renewal of Permit to Operate must be filed thirty (30) days before the expiration date.
