The Republic Act No. 11291 or the **Magna Carta of the Poor (MCP)** was signed into law by President Rodrigo Roa Duterte (PRRD) on 12 April 2019. The MCP safeguards the fundamental rights of the poor and lays down the responsibilities of the government and all of society to alleviate poverty. Thus, the National Anti-Poverty Commission (NAPC) is tasked to facilitate the formulation of the National Poverty Reduction Plan (NPRP) in coordination with the relevant national government agencies (NGAs) through their agency regional offices (AROs), local government units (LGUs), and other government instrumentalities, and the basic sectors/civil society organizations (BS/CSOs).

As part of the preparatory work in popularizing MCP among local stakeholders and in crafting the NPRP, a **2-day Orientation-Workshop** for all the relevant Regional Line Agencies in the country will be facilitated by the NAPC Secretariat to determine and document the local responses of the government for poverty reduction vis-à-vis the five fundamental rights of the poor as mandated by RA 11 291 or the MCP. The activity aims to: a) disseminate the salient features of the MCP and Its Implementing Rules and Regulations (IRR) to both relevant Regional Government Agencies and the PLGUs; b) facilitate the determination of the Programs, Activities, and Projects (PAPs) of the agencies and the current capacity of the PLGUs in as far as the delivery of programs/services related to the five fundamental rights is concerned; c) facilitate the crafting of the agency and Responses Plan for the Achievement of the Five Fundamental Rights.
