

**AMENDING EXECUTIVE ORDER NO. 17 SERIES OF 2023, RECONSTITUTING THE
PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL
(PDRPMC) OF THE PROVINCE OF PALAWAN**

WHEREAS, Section 5, Article II of the 1987 Philippine Constitution is clear and unequivocal as it guarantee the maintenance of peace and order, the protection of life, liberty and property, and the promotion of the general welfare for the enjoyment by all the people of the blessings of democracy;

WHEREAS, Section 2 (a) of Republic Act No. 10121, otherwise known as the "Philippine Disaster Risk Reduction and Management Act of 2010", states that it shall be the policy of the State to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disasters, strengthening the country's institutional capacity for disaster risk reduction and management, and building the resilience of local communities to disasters including climate change impacts;

WHEREAS, pursuant to the provisions of RA 10121, Executive Order No. 17, Series of 2023, entitled: "RECONSTITUTING THE PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (PDRPMC) OF THE PROVINCE OF PALAWAN";

WHEREAS, Section 11 (7) of RA 10121 also calls for the inclusion of the Head of the Gender and Development Office under the Provincial Disaster Risk Reduction and Management Councils, hence this Order.

NOW, THEREFORE, I, V. DENNIS M. SOCRATES, Governor of the Province of Palawan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1. AMENDMENT. Section 2 of Executive Order No. 17, Series of 2023 is hereby amended, to read as follows:

Section 2. MODIFYING CLAUSE. This Executive Order modifies Executive Order No. 17, Series of 2023 by including in the membership of the PDRPMC the head of the Gender and Development Office of the Provincial Government of Palawan.

Section 3. REPEALING CLAUSE. All other orders, issuances, and memoranda issued inconsistent herewith are hereby repealed and/or modified accordingly.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
