The said decision was strengthened in April 12 2005 when former DENR Secretary Michael Defensor declared that all decisions made by former DENR Secretary Gozun be made final and executory. Unfortunately for the heirs of Mr. Mejia, despite all the decisions in their favor, they have yet to acquire their land title, making their ownership of their land unofficial. This prompted Mr. Dequito and his family to seek assistance from my Office.



DECISION

For resolution is the appeal filed by Heirs of Mamerto Delos Reyes represented by Amelia Delos Reyes-Zumaraga and the Heirs of Honorio Mejia represented by Benjamin Mejia Dequito from the Order, dated September 24, 2001 issued by the Regional Executive Director, DENR, Region IV, Roxas Boulevard, Manila, dispositive portion of which reads:

"WHEREFORE, foregoing considered, the CENR Officer in Roxas, Palawan, is directed to cause the subdivision survey of Lot 307, Pls-232, indicating the portion claimed by the Delos Reyes family as mentioned in next preceding paragraph at their expense, the area where the Barangay Hall and school building are located and the actual occupation of other individuals and after the approval of the said plan, the Delos Reyes family are advised to file the appropriate public land application covering the same. The other resultant lots shall be disposed to qualified applicant under the provision of Commonwealth Act No. 141 as amended, particularly of the sales provision thereof. The CENR Officer is further directed to coordinate with the proper/authorized officials in the titling of Barangay Hall and the school."

This case stemmed from the protest filed by Heirs of Mamerto Delos Reyes represented by Amelia Reyes-Zumaraga against the claim of Barangay Chairman Victoriano Lucero of Barangay Retac, Roxas, Palawan covering Lot No. 307, Pls-232, located at Retac, Roxas, Palawan; and protest in intervention filed by Heirs of Honorio N. Mejia, represented by Benjamin Mejia Dequito

against the Heirs of Mamerto Delos Reyes and Victoriano Lucero over the land in dispute.

Protestants-Appellants Delos Reyes alleged that they, by themselves and through their predecessor-in-interest have been the actual occupant, possessor and developers of a parcel of land identified as Lot No. 307, Pls-232 with an area of twenty two (22) hectares more or less, located at Brgy. Retac, Roxas, Palawan. Their grandparent was the first to settle, develop and cultivate the said area, a formerly forest land, as early as 1901 and continuously cleared and developed the same for fifty (50) years until 1949 when the Ninh Bay Mining Corporation undertook mining operation in the area. They further alleged that the protestee Victoriano Lucero had shown undue interest over the land in question, disturbing their peaceful occupation and in unjustifiably threatening to eject them from said land through his whim and caprice.

On the other hand, protestants Heirs of Honorio Mejia represented by Benjamin Mejia-Dequito alleged among others, that their predecessor-in-interest Honorio P. Mejia was a grantee of a parcel of land identified as lot 307 and a portion of lot 306 with an aggregate area of 24 hectares more or less located at Retac, Roxas, Palawan. The late Honorio Mejia filed a Homestead Application No. 75205 on September 16, 1920 with the then Bureau of Lands and the same was approved on October 21, 1939 and recorded as Entry No. 132581.

As to the appellee Victoriano Lucero, he alleged that on May 19, 1985 the Barangay Council of Retac, Roxas Palawan passed an unnumbered resolution requesting the then District Land Officer in Palawan to delineate eight hectares within Lot No. 307 for purpose of relocation of the Barangay site. On January 23, 1993, Kagawad Reynaldo Aborot of the said barangay sent a letter to former President Fidel V. Ramos requesting the allocation of said portion for barangay site. The said letter was indorsed to Land Management Bureau and the latter

forwarded the same to the Regional Office, DENR Region IV, Manila and subsequently the same was referred to CENRO, DENR Roxas Palawan.

.

Acting on the said protest of Delos Reyes, an ocular inspection was conducted by the Regional Office, DENR, Region IV on February 19, 1996 and March 1, 1997. Thereafter, investigation report was submitted and recommended that the lot should be awarded to Delos Reyes family and the other areas to the barangay site.

On September 24, 2001, the Regional Executive Director, DENR, Region IV, issued the assailed order.

Not contended with the said Order, appellants filed their respective Motions for Reconsideration. On April 15, 2002 the Regional Executive Director denied the said motions and ruled for the dismissal of Protest in Intervention filed by Heirs of Honorio Mejia represented by Benjamin Mejia Dequito.

Hence, his appeal, appellants seek the reversal of the assailed order.

A careful evaluation of the facts of the case and evidence adduced, convinced this Office that the appeal of the Heirs of Honorio Mejia, represented by Benjamin Mejia Dequito is meritorious.

Culled from the record of the case, this office finds that a homestead application was filed by the appellants' predecessor Honorio Mejia docketed as H.A. No. 75205 on September 16, 1920 with the then Bureau of Lands (now Land Management Bureau) the entry to the said subject area was approved on October 21, 1939.

In view thereof, appellants Heirs of Honorio Mejia represented by Benjamin Mejia-Dequito acquired a vested right over the land covered by the H.A. No. 75205 and they are regarded as an equitable owner thereof. Actually, even without a patent, a perfected homestead is a property right in the fullest sense. Subsequent law can not deprive vested right already acquired. (Balboa versus Farales 51 Phil. 498)

As to the right of the other parties, the appellants Delos Reyes and Appellee Victoriano Lucero, their right over the land in dispute were not properly established as clearly shown in the assailed order despite the dispositive portion thereof. Moreover, both of them did not file their appeal memorandum and answer to the appellant's memorandum respectively showing that they lost interest in the instant appeal.

The Supreme Court in the case of Gordula versus Court of Appeals (284 SCRA 617) categorically stated:

"One claiming private rights must proved that he has complied with CA 141, otherwise known as the Public Land Act as amended which prescribed substantive as well as the procedural requirement for acquisition of public lands."

Appellants Delos Reyes and Appellee Lucero terribly failed to comply with the above-mentioned provision. As a matter of fact the Regional Executive Director acknowledged that they have not filed any public land application. The Supreme Court likewise declared that possession of public land no matter how long without complying with the requirement of CA 141, confers no right to the possessor (Gordula vs,. CA, ibid)

WHEREFORE, premises considered, the instant appeal filed by Honorio Mejia represented by Benjamin Mejia Dequito is GRANTED. The Order, dated September 24, 2001 is hereby SET ASIDE. Consequently, the Homestead Application by Honorio Mejia be given due course to be substituted by the heirs.

ORDER

For resolution is the Motion to Rectify Decision as to lot erroneously numbered dated 12 July 2004, filed by Intervenors-Appellants Heirs of Honorio Mejia, represented by Benjamin Mejia Dequito, and the Motion for Reconsideration dated 15 December, 2004, filed by Appellants Heirs of Mamerto delos Reyes represented by Amelia Delos Reyes-Zumaraga on 25 January 2005, of the Decision of this Office dated 16 April 2004, the dispositive portion of which reads:

"WHEREFORE, premises considered, the instant appeal filed by Honorio Mejia represented by Benjamin Mejia Dequito is GRANTED. The Order, dated September 24, 2001 is hereby SET ASIDE. Consequently, the Homestead Application by Honorio Mejia be given due course to be substituted by the heirs."

Record shows that the Appellants through their counsel and representative received the assailed decision on 5 May 2004 and 27 April 2004, respectively. DENR Administrative Order No. 87 issued on 28

THE RECORD Management and

December 1990 governs the finality of decision of the Office of the Secretary. Section 5 thereof provides:

"The decision/order of the Office of the Secretary shall become final and executory fifteen (15) days after the receipt by the parties of a copy thereof."

The assailed decision having been received by the Appellants on the aforementioned dates, filed the Motion for Reconsideration only on 25 January 2005, when the assailed decision has long became final and executory. Such being the case, a Motion for Reconsideration directed against a final decision can no longer be entertained. This Office no longer has jurisdiction to entertain the instant Motion for Reconsideration. Section 3, Rule 17 of the Rules of Court which is suppletory in application in administrative proceeding provides, among others:

"If the plaintiff failed $x \times x$ to prosecute its action for unreasonable length of time $x \times x$ the action may be dismissed upon motion of the defendant or upon court's own motion. The dismissal shall have the effect of an adjudication upon the merit, unless otherwise declared by the Court."

This Office has nevertheless, carefully reviewed the records of this case but has found no cogent reason to modify or reverse the assailed decision. Possession and rights over the land in question were thoroughly discussed and fully ventilated in the decision sought to be reconsidered. No new issues were raised to warrant reconsideration or modification of our previous judgment. It is a well-settled rule that a motion for reconsideration that does not make out a new matter sufficiently persuasive to induce modification of judgment will be denied (Philippine Commercial and Industrial Bank v. Escolin, 67 SCRA 202).

With regard to the aforesaid Motion to Rectify Decision as to lot erroneously numbered, the attention of this Office is called in making



This refers to the letter of Mr. Benjamin Dequito for assistance in the issuance of patent in favor of the Heirs of Honorio Mejia over parcels of land located in Retac, Roxas, Palawan covered by Homestead Application No. 75205, Entry No. 132581filed on September 16, 1920 and approved on October 21, 1939. The parcels of land are identified as Lot 307 and a portion of Lot 405, all of Pls-232.

The parcels of land was he subject of DENR Case No. 5598 entitled Heirs of Mamerto delos Reyes, hep, by Amelia delos Reyes-Zumaraga, Appellants, Heirs of Honorio N. Mejia, Rep. by Benjamin Mejia Dequito, Intervenors-Appellants vs. Victoriano Lucero, Chairman, Brgy. Retac, Roxas, Palawan, Appellee. The Decisions issued by Secretary Elisea G. Gozun dated April 16, 2004 and Secretary Michael T. Defensor and April 12, 2005 became final and executory and the corresponding Writ of Execution was issued by the Regional Executive Director of DENR-Region IV-B on February 23, 2006.

Mr. Dequito alleged that to date no patent has been issued in the name of the Heirs of Honorio Mejia in view of the requirement for relocation/verification survey delineating the exact metes and bounds of the area covered by the HA No. 75025 despite the existence of technical descriptions of Lot No. 307 and 405, Pls-232. The requirement is contained in the Memorandum dated February 8, 2007 of RTD Lydia Lopez addressed to the PENR Officer of Palawan.

Based on the Memorandum of RTD Lydia Lopez, the survey returns submitted by the Geodetic Engineer of the Heirs of Honorio Dequito are subdivision surveys identified as Csd-04-026300-D, Csd-04-26301-D and Csd-04-026302-D and not a relocation survey of the area covered by HA No. 75205.

As stated in the Decisions issued by this Office, the area covered by HA No. 75205 are identified as Lot 307 and a portion of Lot 405, all of PIs-232.

In this regard, you are hereby instructed to:

- 1. Verify the actual identification of the lands covered by HA No. 75205 and the actual area covered by the same based on the Homestead Application filed by Honorio Mejia; and
- 2. Based on the result of the verification, explain to Mr. Dequito the need to undertake the relocation/verification survey which will be the basic data needed in the processing of and issuance of the Homestead Patent.

Respectfully submitted is the herein report with the comments and observation relative to the above noted subject in compliance with the office Memorandum dated November 7, 2008 of USEC Eleazar P. Quinto.

Likewise, attached is a fact sheet relative to the background of the H.A. No. 75205 of Honorio Mejia and the lots involved identified as Lot 307, 405 and 907 Pls-232.

Provided hereunder is the Completed Staff Work on the matter to wit.

FACTUAL BACKGROUND

DENR CASE No. 5598- This is a case entitled "Heirs of Mamerto delos Reyes rep. by Amelia delos Reyes Zumarraga-Appellants, Hrs. of Honorio N. Mejia rep. by Benjamin M. Dequito-Intervenors-Appellants vs. Victoriano Lucero, Chairman, Brgy. retac Roxas, Palawan".

Prior to the aforementioned case, the land dispute originally started between the Heirs of Mamerto delos Reyes vs. The Barangay Retac of Roxas, Palawan under DENR Case No. IV-5681 involving Lot 307 only.

On September 24, 2001, an ORDER was issued by the Regional Office relative to DENR Case No.IV-5681 directing the CENRO Roxas Palawan to cause the subdivision survey of Lot 307 indicating the portion claimed by the Hrs. of the Delos Reyes family, the area of the Brgy. Hall and School Bidg. of Retac located and the actual occupation of individuals within the land.

On November 9, 2001 the Hrs. of Honorio Mejia rep. by Benjamin M. Dequito filed the Protest-in-Intervention alleging that the late Honorio Mejia who died sometime in 1940 was a grantee of a parcel of land identified as Lot 907 and portion of Lot 906 with an aggregate area of 24 hectares.

April 15, 2002, an ORDER was issued by RED Samuel R. Penafiel denying the motion for reconsideration filed by the protestants for lack of merit and likewise dismissing the Protest-in-Intervention filed by the Hrs. Honorio Mejia rep. by Mr. Benjamin Dequito.

On June 17, 2003 DENR Case No. 5598 started thru an Order issued by Juliano P. Nacino Director of Legal Services. DENR directing the appellants-Hrs. of Mamorto delos Reyes to submit an appeal memorandum and appelee Victoriano Lucero, Chairman of Brgy. Retac to answer to the appellants memorandum. Further ordering to maintain status quo on the land in dispute.

- I. April 16, 2004, a DECISION was issued by Sec. Elisea Gozun pertinent portion are as follows:
- "...protestants Hrs. of Honorio Mejia rep. by Benjamin M. Dequito alleged among others that their predecessors in interest Honorio Mejia was a grantee of a parcel of land identified as Lot 307 and a portion of Lot 306 with an aggregate area of 24 hectares more or less located at Retac, Roxas, Palawan."...

"Wherefore, premises considered, the instant appeal filed by Honorio Mejia rep. by Benjamin Dequito is granted. The Order dated September 24, 2001 is hereby set aside, Consequently, the Homestead Application of Honorio Mejia be given due course to be substituted by the heirs."

H. On April 12, 2005, an Order was issued by Sec. Michael T. Deseasor the pertinent portion are as follows:

*...For resolution is the Motion dated July 12, 004 to Rectify Decision as to lot graneously numbered filed by Intervenors-Appellants Hrs. of Honorio Mejia rep. Thy Benjamin Mejia Doquito..."

"Wherefore, premises considered, the motion to rectify Decision as to lot "Wherefore, premises considered, the motion to rectify Decision as to lot erroneously numbered filed by the intervenors-appellants is hereby granted. Accordingly, Lot 306 as stated in the subject decision is hereby changed and corrected as Lot 405. The motion for reconsideration filed by the appellants is hereby denied for lack of merit and the decision dated April 16, 2004 of this office is hereby a filiamed and declared final and executory.

Fig. On February 23, 2006, a Writ of Execution was bound by Vicente S. Paragas directing the PENRO/CENRO concerned to execute the Order dated April 16, 2004 relative to DENR Case NO. 5598.

In the investigation report dated January 23, 2008 rendered by LMO III Florante A. Candido, Chief, Land Management Services, CENRO, Roxas, Palawan, it was disclosed that no portion of the subject lots to be recognized as covered by H.A. No.75205 E-132581 of Honorio Mejia and to be patented in their favor were ever entered upon, occupied or cultivated by Honorio Mejia or his heirs to this day which is in violation of the provisions of the Homestead law under Chapter IV of C.A. 141, as amended.

COMMENT AND RECOMMENDATION

We would like to submit comment and observation that if only the concerned legal officer who prepared the Decision on the intervention filed by the heirs of Honorio Mejia and ventured to open or researched on the folder of the subject H.A No. 75205 of Honorio Mejia, the records will show the bar: information on the actual status of the land applied for.

It is indeed very glaring that the allegation submitted by the intervenor (Heirs of Honorio Mejia) were accepted without even validating if the applicant Honorio Mejia was really a homestead grantee, and further, if an ocular inspection was ever conducted, the actual situation obtaining in the area of the subject land would undeniably reveal that the subject land had long been developed into a peaceful community of three (3) urbanized barangays located in the heart of the Municipality of Roxas, Palawan.

The residents of the three Barangays that were living peacefully for so many years in the area and they were the ones that were affected, dismayed and disappointed on the said Decision considering that they were not even parties to the case. The fact that when Mr. Dequito intervened on the case between the Hrs. of Mamerto delos Reyes and the Brgy. Retac under DENR CASE No.IV-5681, the land being disputed or involved is only a portion of Lot 307.

That there is a clear indication of speculation on the Decision with regard to the actual location of the land under consideration in view of the fact that the heirs of Honorio Mejia were very much unsure of the real identity of the land subject of the Homestead Application of their predecessor in interest Honorio Mejia.

Moreover, the contents of the folder of the cited H.A. will show that the H.A of Honorio Mejia had long been recommended for cancellation on February 4, 1958 for reason that the applicant had never touched the land during his lifetime to his death. Apparently, the supposed heirs had miserably failed to enter the land in question. Hence, the allegations of the Hrs. of Honorio Mejia that their ancestor (Honorio Mejia) was a grantee of the subject land is NOT tenable and the same is without factual and legal basis.

WHEREFORE, following the spirit of the Decision "BE GIVEN DUE COURSE" on the cited homestead application, the most appropriate and logical DUE COURSE is that we strongly recommend that the cited Homestead Application No. 75205 of Honorio Mejia be cancelled and the lands subject hereof be declared open for disposition to qualified actual occupants thru sale and/or lease pursuant to the provisions of Sections 59,60 and 61 under Title III Chapter IX of C.A. 141 as amended.

The foregoing recommendation is being submitted in view of the observation and facts presented herein. Attached is a copy of craft of Creder for the cancellation of the said Homestead Application for his approval pursuant to the standard operating procedure as defined by the DENR- Manual of Approval (DAO No. 98-24 Sec. XI page 105). It appearing that the subject Homestead Application was allowed entry on October 21, 1939 by the then Director of Lands which is higher level of authority than the PENRO, in this case, the Regional Executive Director is the signing authority.

Conformably, a Writ of Execution dated February 23, 2006 was issued by RED Vicente S. Paragas directing the PENRO/CENRO concerned to execute the Order dated April 16, 2004.

In the implementation of the cited Order and in consonance with stoudard operating procedure on land disposition, an investigation was conducted and respondented January 23, 2008 was rendered by LMO III Florante A. Candido. Chief Land Management Services. CENRO, Roxas, Palawan. It was indicated in the report "that no portion of the subject lots to be recognized as covered by II.A. No.75205 E-132581 of Honorio Mejia and to be patented in their favor were ever entered upon, occupied or cultivated by Honorio Mejia or his heirs to this day which is in violation of the provisions of the Homestead law Section 14, Chapter IV of C. \[\] 141 as amended."

Corollary thereto, the allegation of the heirs of Honorio Mejia rep. by Benjamin Dequito that their predecessor in interest Honorio Mejia was a grantee of a parest of land identified as Lot 307 and a portion of Lot 306 with an area of 24 hectures more or less located at Retac, Roxas, Palawan is not tenable.

Purthermore, perusal of the records of the cited Homestead Application, it was disclosed from the report dated February 4, 1958 of Land Investigator Melchor P Pacaldo, the applicant (Honorio Mejia) had never touched the land since the approval of his application during his lifetime to death and further recommended the cancellation of the Homestead. Clearly, applicant Honorio Mejia failed to comply with the residence and cultivation requirements of the homestead law. Hence, the allegation that applicant Honorio Mejia was a grantee of the subject land had no factual and legal basis

LMO III Candido, in his report has recommended the cancellation of H.A. No. 75205 of Honorio Mejia it being the logical and appropriate DUE COURSE.

IN VIEW OF THE FOREGOING, H.A. No. 75205 of Honorio Mejia, as it is hereby ordered CANCELLED, and whatever amount has been paid on account thereof are forfeited in favor of the government. Furthermore, the subject land is likewise declared OPEN for disposition to qualified actual occupants thru sale under least pursuant to the provisions of Chapter IX of C.A. 141 as amended.



This pertains to the Second Motion for Reconsideration dated 3 October 2010, filed by the Heirs of Mamerto Delos Reyes, through their Attorney-in-Fact Amelia Delos Reyes-Zumaraga; and the Letter-Request of the Heirs of Honorio Mejia for the Issuance of Patent dated 10 January 2010, and their 10 July 2012 Request for an Order for Immediate Execution of DENR No. 5598, through attorney-in-fact, Benjamin M. Dequito. These incidents were the offshoot of the Order of then DENR Secretary Michael T. Defensor, dated 12 April 2005, the dispositive portion of which reads:

"WHEREFORE, PREMISES CONSIDERED, the Motion to Rectify Decision as to lot croneously numbered filed by the Intervenors-Appellants is nereby GRANTED. Accordingly, lot 306 as stated in the subject decision is hereby changed to and corrected as lot 405. The Motion for Reconsideration filed by the Appellants is hereby DENIED for lack of merit, and the Decision dated 16 April 2004, of this

C ze is hereby AFFIRMED and a gred FINAL and EXECUTORY."

The instant controversy was originally docketed as DENR Case No. IV-5681 entitled "Hrs. of Mamerto Delos Reyes, Rep. by Amelia Delos Reyes – Zumaraga, Protestants versus Victoriano Lucero, Chairman, Brgy. Retac, Roxas, Palawan, Protestee" and the subject matter was Lot No. 307, Pls-232 with an approximate area of 22 hectares, located in Barangay Retac (formerly New Barbacan), Roxas, Palawan.

Records show that a formal investigation was conducted and an Order was issued on 24 September 2001 by Samuel R. Peñafiel, then Regional Executive Director (RED), DENR-Region IV-B (MIMAROPA), Roxas Blvd., Manila, the decretal portion of which reads as follows:

"WHEREFORE, foregoing premises considered, the CENR Officer in Roxas, Palawan, is directed to cause the subdivision survey of the Lot 307, Pls-232, indicating the portion claimed by the delos Reyes family, as mentioned in the next preceding paragraph at their expense, the area where the Barangay Hall and School Building are located and the actual occupation of other individuals, and after the appropriate public land application cavering the same. The other resultant lots shall be disposed of to qualified applicants under the provisions of Commonwealth Act No. 141, as amended, particularly on the Sales provisions thereof. The CENRO Officer is further directed to coordinate with the proper/authorized official/s in the preparation of the necessary documents/papers for the eventual issuance of munispents of title to the portions of land occupied by the Barangay Hall and the School.

On 9 November 2001, the Heirs of Honorio Mejia, represented by Benjamin Mejia Dequito, filed a Protest-in-Intervention alleging that the late Honorio Mejia, who died sometime in 1940, was a grantee of a parcel of land identified as Lot No. 907 and portion of Lot No. 906 with an aggregate area of 24 hectares, located in Retac, Roxas, Palawan; that long before his death, Honorio DENR Case No. 5598

Mejia filed on 16 September 1920 Homestead Application (HA) No. 75205 which was allegedly approved on 21 October 1939 with Entry No. 132581; and that they are desirous to pursue their claim.

On 18 December 2001, the Heirs of Honorio Mejia filed a Supplement to the Protest-in-Intervention, alleging in substance that there were subsequent changes made as to the denominations of the lots appearing in the Roxas Cadastre, Cad-862-D, approved on 9 December 1988. Lot No. 907 in the name of Honorio Mejia was allegedly changed to Lot No. 307, now Lot No. 1132; and that a portion of Lot No. 906 was changed to Lot No. 405, now Lot No. 1128, but did not submit any proof or evidence that such was the case.

On 15 April 2002, then RED Samuel R. Peñafiel issued an Order, the dispositive portion of which reads:

"WHEREFORE, viewed from the foregoing, the Motion for Reconsideration filed by the herein Protestants is hereby DENIED for lack of merit.

Likewise, the Protest-in-Intervention filed by the Heirs of Honorio N. Mejia, represented by Benjamin Mejia Dequito, is hereby as it is ordered DISMISSED for lack of merit."

On 16 May 2002, the Heirs of Honorio Mejia filed a Motion for Reconsideration from the Order dated 15 April 2002 which was subsequently denied in another Order dated 30 May 2002 of then RED Penafiel.

The Heirs of Honorio Mejia, represented by Benjamin Mejia Dequito, filed a Motion for them to intervene with the appeal in DENR Case No. 5598, entitled Heirs of Mamerto Delos Reyes, Rep. by Amelia Delos Reyes Zumaraga, Appellant versus Victoriano Lucero, Appellee, the subject matter of which case

were Lot No. 307 and portion of Lot No. 306, Pls-233, located in Retac, Roxas. Palawan.

Dissatisfied with the Orders, dated 15 April 2002 and 30 May 2002, of then RED Penafiel, the Heirs of Honorio Mejia, represented by Benjamin Dequito, filed their appeal before this Office alleging that the late Honorio Mejia was a grantee of a parcel of land identified as Lot No. 307 and a portion of Lot No. 306, both situated in Roxas, Palawan, with an aggregate area of twenty four (24) hectares, and the appeal filed by the Heirs of Mamerto Delos Reyes, represented by Amelia Delos Reyes Zumaraga, from the Order dated 24 September 2001 of then RED Penafiel directing the subdivision survey of Lot No. 307, PIs- 233 to indicate the portions claimed by the Delos Reyes family.

On 16 April 2004, a Decision was rendered by then DENR Secretary Elisea Gozun, the dispositive portion of which reads as follows:

"WHEREFORE, premises considered, the instant appeal filed by Honorio Mejia represented by Benjamin Mejia Dequito is GRANTED. The Order dated September 24, 2001 is hereby SET ASIDE. Consequently, the Homestead Application by Honorio Mejia be given due course to be substituted by the heirs."

On 12 July 2004, the Heirs of Honorio Mejia filed a Motion to Rectify Decision praying that correction be made to the alleged typographical error such that Lot No. 306 should be made to read as Lot No. 405. The Heirs of Mamerto Delos Reyes, on the other hand, filed a Motion for Reconsideration. Acting on the said motions, then DENR Secretary Michael T. Defensor issued the assailed Order 12 dated April 2005 granting the Motion to Rectify Decision filed by Intervenors-Appellants Heirs of Honorio N. Mejia, represented by Benjamin

April 2004.

On 23 February 2006, a Writ of Execution was issued by then RED Vicente S. Paragas, directing the Provincial Environment and Natural Resources Office (PENRO)/Community Environment and Natural Resources Office (CENRO) concerned to execute the Order dated 16 April 2004, of then DENR Secretary Gozun giving due course to HA No. 75205 of Honorio Mejia.

On 9 December 2008, after the requisite investigation and evaluation of the pertinent documents relative to the HA of Honorio Mejia, an Order was issued by Marcial C. Amaro, Jr., then RED, DENR-Region IVB (MIMAROPA), the dispositive portion of which reads as follows:

"IN VIEW OF THE FORECOING, H.A. No. 75205 of Honorio Mejia, as it is hereby ordered CANCELLED and whatever amount has been paid on account thereof are prefeted in favor of the government. Furthermore, the subject land is likewise declared OPEN for disposition to qualified occupants thru sale and/or lease pursuant to the provisions of Chapter IX of C.A. 141 as amended."

On 5 February 2009, Benjamin Dequito filed a Vigorous Opposition with Manifestation from the said 9 Decembe: 2008 Order which then RED Amaro, Jr. subsequently dismissed through the Order dated 14 April 2009, disposed of as follows:

"WHEREFORE, premises considered, the 'Vigorous Opposition and Manifestation' filed by Benjamir M. Dequito, Atty-in-Fact of Heirs of Honorio Mejia is hereby, as it is, ORDERED DISMISSED for lack of merit."

No Notice of Appeal or Motion for Reconsideration was filed by any of the parties from said Order of 14 April 2009

Reconsideration; and 2. Whether or not the Order dated 9 December 2008, of then RED Amaro, Jr. invalidates the Decision dated 16 April 2004, of then DENR Secretary Gozun.

The Second Motion for Reconsideration (MR) filed by Appellants. Heirs of Mamerto Delos Reyes cannot be given due course. Well-settled is the rule that a Second Motion for Reconsideration is a prohibited pleading and therefore cannot be given due course by this Office (See Tagaytay City vs. De Los Reyes, GR No. 166679, 27 January 2010.

Significantly enough, it is the considered view of this Office that the Order dated 9 December 2008 of then RED Amaro, Jr. is not in contravention and does not invalidate the Decision of this Office dated 16 April 2004.

A careful perusal of the 16 April 2004 Decision of then DENR Secretary Gozun will readily show that no vested right was bestowed to the Heirs of Honorio Mejia. What was recognized in the said Decision was the existence of the HA of Honorio Mejia which was GIVEN DUE COURSE. It follows, therefore, that the HA must undergo the whole gamut of the administrative processes to determine whether or not the applicant is qualified and has complied with all the legal requirements that will lead to a grant.

In the case at bar, applicant Honorio Mejia and his predecessor-in-interest were found wanting of the basic qualifications and failed to show that they complied with the impositions of the law on the requisite occupancy, cultivation and introduction of improvements on the applied lot that will lead to a grant DENR Case No. 5598

from the State. Trinent portions of the Order dz 19 December 2008 of then

RED Amaro, Jr. are hereto quoted:

"In the implementation of the cited Order and in consonance with standard operating procedure on land disposition, an investigation was conducted and a report dated January 23, 2008 was rendered by LMO III Florante A. Candido, Chief, Land Management Services, CENRO, Roxas, Palawan. It was indicated in the report 'that no portion of the subject

lots to be recognized as covered by H.A. No. 75205 E-132581 of Honorio Mejia and to be patented in their favor were ever entered upon, occupied or cultivated by Honorio Mejia or his heirs to this day which is in violation of the provisions of the Homestead Law Section 14, Chapter IV of C.A. 141, as amended.'

Corollary thereto, the allegation of the Heirs Of Henorio Mejia rep. by Benjamin Dequito that their predecessor in interest Honorio Mejia was a grantee of a parcel of land identified as Lot 307 and a portion of Lot 306 with an area of 24 hectares more or less located at Retac, Roxas, Palawan is not tenable.

Furthermore, perusal of the records of the cited Homeslead Application, it was disclosed from the report dated February 4, 1958 of Land Investigator Melchor P. Pacalao, the applicant (Honorio Mejia) had never touched the land since the approval of his application during his lifetime to death and further recommended the cancellation of the Homestead. Clearly, applicant Honorio Mejia failed to comply with the residence and cultivation requirements of the homestead law. Hence, the allegation that applicant Honorio Mejia was a grantee of the subject land had no factual and legal basis."

Moreover, '[a] judgment becomes 'final and executory' by operation of law. Finality becomes a fact when the reglementary period to appeal lapses and no appeal is perfected within such period. As a consequence, no court (not even this Court) can exercise appellate jurisdiction to review a case or modify a decision that has become finil.

When a final judgment is executory, it becomes immutable and unalterable. It may no longer be modified in any respect either by the court which rendered it or even by this Court. The doctrine is founded on considerations of public policy and sound practice that, at the risk of occasional errors, judgments must become final at some definite point in time.' (See Social Security System. v. Isip, G.R. No. 165417, April 7, 2007, 520 SCRA 310)

WHEREFORE, from the foregoing, the Second Motion for Reconsideration filed by the Heirs of Mamerto Delos Reyes and the Request for Issuance of Patent



filed by the Heirs of Honorio Mejia are hereby DENIED.

The Order, dated 9 December 2008, issued by the Regional Executive Director, DENR-Region IVB (MIMAROPA), is AFFIRMED en toto.



This has reference to your Memorandum dated May 28, 2013 relative to the Letter dated April 08, 2013 of Edna Miraflores-Gabo. This also answers your previous Memorandum dated January 4, 2013 on the feedback and compliance regarding DENR Case No. 5598.

Please be informed that the subject land involved in the Miraflores vs. Ventilacion case (Lot 405, portion) was inadvertently included in the Decision dated April 16, 2004 by then Secretary Gozun and the April 12, 2005 Order issued by then Secretary Defensor in the case entitled "Heirs of Manate deles Reyes, Represented by Amelia delos Reyes Zumarraga, Appellant vs. Victoriano Lucero, et. al. Appellee versus Heirs of Hanorio Mejia, Represented by Benjamia Dequito, Intervenor" docketed as DENR Case No. 5598 in favor of the Heirs of Honorio Mejia.

Based on the foregoing facts, this Office is constrained to act on the pending Claims and Conflict case between the Heirs of Celso Miraflores vs. Ruben Ventilacion over Lot 405 (portion) as Benjamin Dequito, who is the representative of the Heirs of Honorio Mejia, is actively following up the implementation of the aforecited Decisions rendered in DENR Case No. 5598. Early this year, during his visit to the Legal Division he expressly manifested his desire to have an amicable settlement with all parties who had claims over the lots included in DENR Case No. 5598.

That based on his express manifestation of an amicable settlement, an Alternative Dispute Resolution (ADR) Team was created by the Regional Office, but there was no settlement reached by the parties involved, primarily because of the reluctance of Benjamin Dequito himself.

Please be informed that the ADR was not for the Gabo case, but for the

the Order dated Decem 9, 2008 signed by the Regional Jecutive Director now Assistant Secretary for Field Operations Marcial C. Amaro, Jr. However, the implementation was unsuccessful because of the circumstances of the involved lots, which have been for many years now occupied by numerous households and the whole place is already an established community.

On February 5, 2009, the Heirs of Honorio Mejia filed a Vigorous Opposition and Manifestation against the Order dated December 9, 2008 which was dismissed in the Order dated April 14, 2009 signed by then RED Amaro. The same Order was appealed by the Heirs of Honorio Mejia before the Office of the Secretary. The appeal was apparently resolved through a Memorandum dated October 28, 2009 issued by then Assistant Secretary for Legal Atty. Juan Miguel Cuna reiterating that the homestead application of the Heirs of Mejia be given due course.

Presently, per information from the Legal Service of the DENR Central Office, there is a let dated March 29, 2009 filed by the Heirs of Celso Miraflores, represented by Edna diraflores-Gabo, which was the subject of an investigation of that Office, but has yet to be resolved from their end.

Relative thereto, may we seek clarification on the following:

- a) In the Memorandum dated October 28, 2009 of then Assistant Secretary Cuna reiterating that the homestead application of the Heirs of Honorio Mejia be given due course, can we again implement the same considering that it has already been the subject of implementation which led to the Order dated dated December 9, 2008 signed by then RED Marcial C. Amaro, Jr.?
- b.) On DENR Region IV-B Case entitled "Heirs of Celso Miraflores, rep. by Edna Miraflores-Gabo vs. Ruben Ventilacion, et. al.." are we barred from conducting investigation on their protest just because the lot subject of their case was inadvertently included in DENR Case No. 5598?

Blatant disregard by your assistant secretaries, undersecretaries, regional directors, legal officers, and provincial and community environment and natural resources officers of the Decisions/Order by two of your predecessors to issue a patent to my clients (which Orders have attained absolute finality).

Dear Secretary Paje:

I write in behalf of my clients, Heirs of Honorio Mejia, to inform you as the Secretary of your Department of the above-named subject. This is to give your office the last opportunity to comply with your own rules and the laws of the land before we elevate the matter to the Office of the President instead of bringing the matter to court.

I would like to inform you in the strongest terms possible of the established practice in your office to give bona fide claimants the run around by issuing memoranda, orders and letters (giving the false impression that there is something being done) until the claimant gets exhausted by all the administrative "activity" and drops off the hopeless merry-go-round.

I am listing the last three communications we sent to three of your most senior personnel (with copies attached), which will summarize my clients' claim and entitlement to a Homestead/Free Patent, and the Orders and the issuances your underlings issued in response thereto in order to thwart the issuance of the said patent.

1. A letter to RED EDGARDO O. GALEON (Annex "A"), Department of Environment and Natural Resources, Region IV-B MIMAROPA, DENR By the Bay, 1515 Roxas Blvd. Ermita, Manila, requesting the following:

Compliance with the Indorsement by the Asst. Secretary, General Legal Services, Atty. Fidel J. Exconde, Jr dated 1 March 2006; Memorandum by the OIC, Asst. Secretary for Legal, Atty Juan Miguel T. Cuna dated 28 October 2009; Memorandum by the then RED Concordio D. Zuniga,

for Field Operations Regidor M. de Leon dated 14
September 2012 (all attached) directing you and your predecessors to "undertake issuance of a homestead patent in favor of' the Heirs of Honorio Mejia, "effect the execution of the final and executory decisions of then Secretary Elisea Gozun on 16 April 2004 and then Secretary Michael T. Application of the proper sanction for the refusal by RED EDGARDO O. GALEON of DENR Region IV-B MIMAROPA, DENR By the Bay, 1515 Roxas Blvd., Ermita Manila to comply with your Memorandum dated 14 September 2012 directing RED Galeon to investigate the matter of the anomalous New Order of Investigation on DENR Case No. 5598 (and not another land investigation) and to "submit a report" of his investigation of the said anomalous new order of investigation (not another land investigation on the pretext that some entities were not party to DENR Case No. 5598)

In response to the said letter, ASEC Marcial Amaro, Jr. in a Memorandum directed/ordered the RED on 4 January 2013 to advise him of "the compliance to the Memoranda dated 28 October 2009 by ASEC for Legal and dated 14 September 2012 instructing the RED to investigate new order of investigation within 2 weeks from receipt thereof. A copy of the said memorandum is attached herewith as Annex "B-1".

3. Letter to ASST. SEC. ANSELMO C. ABUNGAN (Annex "C"), Asst. Specretary for Legal Services, Department of Environment and Natural Resources, Visayas Ave., Quezon City requesting the following:

Application of the proper sanction for the refusal by RED EDGARDO O. GALEON of DENR Region IV-B MIMAROPA, DENR By the Bay, 1515 Roxas Blvd., Ermita Manila to comply with the Indorsement by your office dated 1 March 2006 directing him and his predecessors to "undertake issuance of a homestead patent in favor of" the Heirs of Honorio Mejia


For our efforts, the Regional Technical Directors for Lands issued a Memorandum to the Chief of the Legal Division lamely inviting his attention to the instruction requiring the submission of a report or resolution on non-issuance of the patent within two weeks upon his receipt of the said memorandum.


- 4. Instead of issuing the said patent, and before we received our copy of the said memoranda for the said purpose, RED Galeon created an alternative dispute resolution team, referring to the subject land as "disputed Lot 405, PLS 232" despite its having been decided with finality, going back to stage one of the process and even involving again spurious claimants who have already been declared as with baseless claims on the land. A copy of the special order creating the said team is attached herewith as Annex "D".
- 5. My clients filed a proposal with the team headed by one Atty. Gandhi Gagni-Flores, but which was ignored by the other claimants having found an ally in the team which intends to give them hope of acquiring a portion of the land. A copy of my clients' proposal is attached herewith as Annex "E". The CENRO Roxas, Palawan was given opportunity to participate in the said proceedings despite being the supposed mediator between the parties.
- 6. During the supposed alternative dispute resolution proceeding, however, on the date that the proposals were discussed on April 10, 2013 the PENRO/CENRO Roxas, Palawan, resumed the construction of their concrete fencing of Lot 405, Pls 232 despite the agreement among the parties to maintain the status quo (copies of photographs of the construction are attached herewith as Annexes "F" to "F-8"). The CENRO continued its construction up to April 15, 2013 and even up to this day as shown by dated photos of their activities.
- 6. Seeing that the process will just further extend the process for another decade, we now come to your level as Secretary of your department as a last resort before we proceed to the Office of the President and to the media to expose the wicked system embedded in your office to frustrate the valid claims of members of the public using a devious pattern of unending and ceaseless issuance of memoranda, orders, directives and other useless written instructions that accomplishes nothing but false hopes and desperation in the public.



We wish to inform you again that the subject of our complaint has been the subject of **DENR Case 5598**. Relevantly on April 16 2004, DENR Secretary Elisea G. Gozun reversed the Decision of the Regional Office (DENR Case 5681) in our favor. A copy of said Decision is herein appended as "Annex-A".

Thereafter, on 12 April 2005, the DENR Case 5598 was declared Final and Executory again in our favor. A copy of the said Order is hereto attached as "Annex - B".

Consequently, on 23 February 2006, The Regional Executive Director Vicente S. Paragas issued a Writ of Execution Order directing the CENRO/PENRO Juan Dela Cruz to execute the order the DENR Secretary.

As part of the process we conducted a Relocation/ Verification / Subdivision surveys. Our survey authority/s were granted by the Land Management Office in the person of Florante C. Candido and CENRO Wilfredo R. Angeles.(deceased) In addition, the CENRO and LMO ask legal advice to the Office of the DENR Secretary.

In Short, there is an existing Cadastral Survey which shows our name approved by the Bureau of Lands in 1956 and with an approved Technical Descriptions particularly of the lots 307, Pls-232 and lots 405, Pls-232, an endorsement Order was then issued to grant us the our Homestead Patent being the prevailing party, Endorsement is hereto marked as "Annex-C".

Not contented to the DECISION/ORDER given to us, **aggrieved** parties filed their protest to the office of the President. The reply of the Legal Department under the Office of the President denying their petitions is hereto attached as "Annex-D".

On September 19, 2008, we requested an assistance for the issuance of our Patent to the Director of the Land Management Bureau, Binondo, Manila as the Cadastral Surveys emanates from them and they supervise all regional offices. Accordingly the request was endorsed to the USEC Eleazar P. Quinto, Undersecretary for Field Operations and Staff Bureaus for comment and immediate assistance. A copy of his Memorandum is hereto appended as "Annex-E".

The Regional Executive Director on the other hand instructed the Regional Technical Director Lydia S. Lopez pertaining to the said request. Regional Technical Director Lydia S. Lopez, who is accused by the undersigned to the Ombudsman replied with her recommendations and Draft Order of Cancellation against Heirs of Honorio N. Mejia. Attached is the Memorandum of RTD Lopez and Draft Order signed on the same very dates December 09, 2008 by the RED Marcial C. Amaro, Jr. (Annex-F and Annex-G):

In absence of due process as well as of Notice and Hearing the Heirs of Honorio N. Mejia filed our opposition to that illegal action of said Regional Office. Believing and without losing hope to the rule of justice, we filed our sentiments to the higher office under the office of the DENR Secretary.

On February 9, 2009, Heirs of Celso Miraflores filed their protest to the office of the DENR Secretary, A copy of the reply letter of Atty Juan Miguel T, Cuna OIC, ASEC for Legal is hereto attached as (Annex- H1)

On June 29,2009 the Memorandum order was issued by Atty Miguel T. Cuna, ASEC for Legal, Office of the DENR Secretary ordering "Depth Evaluation of DENR Case 5598" directing Atty. Ricky A. Arzadon and Mr. Manuel Aurelio C. Trampe to conduct evaluation of the case and submit reports within 15 days period. (Annex- H2)

About four (4) months had passed an order from ASEC for Legal, Atty. Miguel T. Cuna under the office of the DENR Secretary issued an order through a Memorandum Order dated October 28, 2009, directing Regional Executive Director Marcial T. Amaro, Jr. to rectify and effect the subject Final and Executory decisions made by the DENR Secretary and submit compliance hereof.(Annex – H3)

On January 04, 2013 after our relentless request to the office of the DENR Secretary , ASEC for Field Operations and Staff Bureaus , **The Regional Executive Director Marcial T. Amaro, Jr. rectified and** issued a Memorandum Order entitled "FEEDBACK AND COMPLIANCE REGARDING DENR CASE 5598". The Memorandum Order requires compliance within two weeks. See attached MEMO as "Annex-J".

On January 19, 2013 we seek the help of the Office of then President Benigno C. Aquino for continued inaction but to our surprise the DENR case 5598 was indorsed (Almost 3 years in Malacanang) to the Office of the DENR Secretary only on June 27, 2016 requesting for speedy issuance of our valid Patent. As usual the Chief of Staff, USEC Analiza Rebuelta-Teh of the DENR Secretary replied through the office of the Hon. Mildred Yovela S. Umali-Hermogenes referred as "Annex – K" for appropriate action without any comment that said case has been set aside illegally.

As noticed, All letters and memo made by the office of USEC Analiza Rebuelta-Teh are just a moro moro and without clear positive result.

In fact on February 14, 2013 an Alternative Dispute Resolution (ADR) was created by the Regional Office under the office of Regional Executive Director Edgardo O. Galeon. The ADR was created merely to protect and make justification on their illegal occupation particularly the lot 405, Pls-232 as cited in the Decision. We reported said actions direct to the office DENR Secretary Ramon J. Paje. "Annex-L"

On May 28,2015, A suspension of survey authority and conduct of untitled lands, and acceptance and processing of public land applications in the entire province of Palawan was issued by USEC Demetrio L. Ignacio, Jr. and newly appointed Regional Director Oscar. Dominguez. All of these are part their strategy to extend the long wait and agony of our family. The purpose of said suspension was clearly stated to investigate DENR Personnel and not against DENR case 5598. Marked as "Annex-M"

On August 05, 2016 we wrote the Office of the President under the President Duterte's Administration it was immediately indorsed to the Office of the DENR Secretary for action on September 30, 2016 by Director Jaime Llaguno Mabilin referred as "Annex-N"

As to our surprise, the Office the DENR, ASEC for Legal, Atty. Anselmo C. Abungan (deceased) issued another order dated April 27,2016 cancelling the Decisions and Orders granted by the Office of the DENR Secretary citing the order of Regional Executive Director Marcial T. Amaro, Jr. dated December 08, 2009. This order is obviously

illegal as cited in the rules of Court (Rule 39 of Final and Executory Decisions). The invalid Order is Marked as "Annex-O"

This is ridiculous maneuver made by no other than of certain Atty Ricky A. Arzadon, Chief Investigation and Litigation Division, Legal Services. Attached herewith is the exact letter explanation of Atty Ricky A. Arzadon to the Office of the Ombudsman noted by then still alive Atty. Anselmo C. Abungan dated July 18, 2012.

We doubt the credibility of their report as the Depth evaluation has been done that the alleged investigations which become moot and academic upon the issuance of the October 28, 2009, much to say the request for issuance of Patent is mandatory upon the finality order of DENR Secretary dated 2005. If the signature of the Former ASEC Anselmo C. Abungan has been forged its another thing to be considered. (Annex-P)

Consonantly, in 2007, the principal reason cited by the Regional office before for non-issuance of the corresponding homestead patent is the need to have another survey done to delineate the metes and bounds of the area covered by the homestead patent application but as per records that verification and relocation has been done. Now, on the New Order, the issue raised is that, no portion of the land was ever entered upon occupied or cultivated by the Heirs of Honorio N. Mejia. The Heirs resides to the area since birth and the acts of the CENRO Roxas, Palawan in illegal constructing a building and perimeter fence on our land was carried during the ADR period which we demanded a status auo, shown by the absence of any building permits and the said Land Management Officer Florante Candido act of declaring the property for tax purposes, reveals the institutional and personal interest the said CENRO office has on our land when he submitted a fabricated report against us,.Such blatant disregard of our rights and the prevailing laws of the land has no place in a Democratic society, especially for a Department duly tasked to recognize citizen's right to our land.

We all due respect, the Decision (as clarified by the 12 April 2005 Order) clearly identified subject lots which shows metes and bounds of the areas covered by the homestead application approved on October 21,1939 with an approved Cadastral maps under Pls-232 dated October 16,1956. All verification and investigations had been done prior to the promulgation of the case obtainable under the custody of the DENR. The absence of

occupation and cultivation being the basis of the cancelation is untrue and made intentionally by the personnel being investigated.

We are still hopeful that this government will truly fight and eliminate graft and corruption little by little with our help, as citizens as this administration promotes. Good Governance. The DENR personnel have committed several abuses already, Office Status Quo's have been violated, falsification of reports and forgery are very common practice by them in violation of Anti-Red Tape law. All evidences are hereby appended and marked as "Annex -Q; Annex - R, Annex - S, Annex - T and "Annex - U."

We would like to request your office to urge the Office of the DENR Secretary, DENR Regional Office, PENRO and CENRO offices to PLEASE issue THE HOMESTEAD PATENT in the name of HEIRS OF HONORIO N. MEJIA, with the application of proper sanctions to the people who committed the wrongdoings if necessary.



This refers to your letter-request dated February 04, 2020 addressed to then President Rodrigo R. Duterte urging the DENR Offices to "please issue the Homestead Patent in the name of Heirs of Honorio Mejia, with the application of proper sanctions to the people who committed the wrongdoings if necessary."

Records show that a letter dated April 11, 2019 from then Regional Executive Director Henry A. Adornado was sent to Atty. Albert M. Pedrosa (Counsel for the Heirs of Mejia) in response to the latter's undated letter¹ regarding DENR Case No. 5598 entitled "Heirs of Mamerto N. Delos Reyes, Represented by Amelia P. Delos Reyes-Zumaraga, Appellants; Heirs of Honorio N. Mejia, Represented by Benjamin Mejia Dequito, Intervenors-Appellants - versus- Victoriano M. Lucero, Ex-Chairman, Brgy. Retac, Roxas, Palawan, Appellee."

The gist of said undated letter shows that it contains the same issues raised in the letterrequest dated February 04, 2020.

On July 30, 2018, then Regional Executive Director Henry A. Adornado issued a memorandum transmitting the records of DENR Case No. 5598 to the OIC, PENR Officer, Palawan (attention OIC, CENR Officer, Roxas, Palawan).

We are reiterating the contents of which, viz:

"This refers to the records of the above-cited case relative to the issuance of an Order dated April 27, 2016 issued by then Acting Assistant Secretary for Legal Services Atty. Anselmo C. Abungan, the dispositive portion of which is hereunder quoted:

"WHEREFORE, from the foregoing, the Second Motion for Reconsideration filed by the Heirs of Mamerto Delos Reyes and the Request for Issuance of Patent filed by the Heirs of Honorio Mejia are hereby **DENIED**.

The Order, dated 9 December 2008, issued by the Regional Executive Director, DENR-Region IVB (MIMAROPA) is AFFIRMED en toto."

This refers to your letter dated January 9, 2019 addressed to the PENR Officer, Palawan regarding the above-cited subject.

In the said letter, you stated that:

"Surprisingly, RED Anaro who is a mere underling of the two secretaries of the DENR, attempted to vacate, reverse and set aside the decision of his superiors by issuing his 9 December 2008 Order. That should not be allowed and with this letter, I, as the lawyer representing the Heirs of Honorio Mejia, would like to make it clear here and now that the Order of RED Amaro is illegal and my clients are requesting your office to stop implementing the same and in its stead, implement and enforce the DENR Decision dated 16 April 2004.

Please be informed also that my clients, tacking their possession through their predecessor-in-interest/s, are still in actual physical possession of Lots 307 and 405, Pls-232 since 1920 and up to the present time. That was the factual finding in the 16 April 2004 Decision and in the 12 April 2005 Order of the DENR, and, thus, must be respected by the subordinate officers of the DENR"

Records show that the issues you raised are squarely addressed by then Acting Assistant Secretary Anselmo C. Abungan per Order dated April 27, 2016 in this wise:

"Significantly enough, it is the considered view of this Office that the Order dated 9 December 2008 of then RED Amaro, Jr. is not in contravention and does not invalidate the Decision of this Office dated 16 April 2004.

A careful perusal of the 16 April 2004 Decision of then DENR Secretary Gozun will readily show that no vested right was bestowed to the Heirs of Honorio Mejia. What was recognized in the said Decision was the existence of the HA of Honorio Mejia which was GIVEN DUE COURSE. It follows, therefore, that the HA inust undergo the whole gamut of the administrative process to determine whether or not the applicant is qualified and has complied with all the legal requirements that will lead to a grant.

In the case at bar, applicant Honorio Mejia and his predecessor-in-interest were found wanting of the basic qualifications and failed to show that they complied with the impositions of the law on the requisite occupancy, cultivation and introduction of improvements on the applied lot that will leud to a grant from the State. xxx-xxx"

We hope we have enlightened you regarding the matter.
