### **MOTION**

Comes now unto this honorable office of President Marcos and DENR Secretary Yulo-Loyzaga and DENR Regional Director respectfully filed this Motion for valid reasons to wit:

That the supporting prima facie evidence and valid documents of tax declaration issued on 12th of May 2014, by the municipal assessor of San Jose certified that Julian Condes had a parcel of land at Hinulogan, San Jose. Julian Condes heirs were not able to live in the area because of the following valid reasons:
