Due to urgency of this matter, this Office is furnishing you an **advance copy** of the Memorandum for all DENR Regional Offices regarding the submission of data on reversion cases pursuant to Special Order (SO) 2021-716.

Please be reminded that the above-mentioned SO has mandated the Anti-Illegal Land Titling Committee (AILTC) to conduct a continuing inventory of all illegal/irregularly issued registered patents/land titles nationwide.

The SO also required the Chiefs of Legal Division of DENR-Regional Offices to maintain a database of reversion cases prosecuted within their jurisdiction and submit to the Committee a yearly report on these cases on or before the 30th of January, without prejudice to the Chairperson's request for a more frequent or for an earlier submission.
