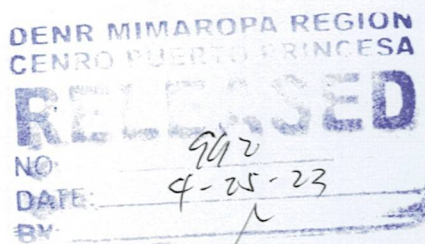

4. Noong **ika-7 ng Abril 2021**, bilang katugunan sa inyong reklamo, ang tanggapang ito ay lumihap sa inyo at ipinarating ang mga sumusunod:

San Manuel, Puerto Princesa City, informing him that he failed to mention the lot no. or the name of the owner of OCT 859, hence, the office could not provide the requested information.
 - On July 14, 2020-Letter of the CENRO to G. Carlito Alcovindas relative to his letter complaint addressed to President Rodrigo R. Duterte informing him to provide the office with the specific lot number of the area covered by his letter-complaint.
 - Again informing that the land in question (44-B, Csd-4A-002376-D) having been registered with Original Certificate of Title No. 859 ceased to form part of the public domain and therefore outside the authority and jurisdiction of the DENR already, hence, the office is no longer in position to resolve the said conflicting claim. It is further advised to lodge the complaint before the regular court of justice.
 - With regard to the second issue, which is the parcel of land covered by Proclamation 718 issued on October 19, 2004, amending Executive Order No. 67 dated October 15, 1912, which established the Iwahig Prison and Penal Farm in Palawan, by segregating portions of the land embraced therein and declaring the same as civil reservation for resettlement and agricultural sites purposes, it is also advise that you directly coordinate with the Local Inter-Agency Committee (LIAC) and/or the City Government of Puerto Princesa who has administrative jurisdiction over the said proclaimed area.

5.
