**COMPLAINT-AFFIDAVIT** 

I, **FREDDERICK V. URBANO**, of legal age, Filipino, married, and a resident of Barangay Tayamaan, Mamburao, Occidental Mindoro, after being duly sworn to in accordance with law hereby depose and state that:

- 1. I am filing an administrative case against Respondent Anastacio A. Santos, of legal age, Filipino, married, and currently the Community Environment and Natural Resources Officer of Sablayan, Occidental Mindoro with office address at Barangay Sto. Niňo, Sablayan, Occidental Mindoro, where notices and processes of this Honorable Office may be served;
- 2. I have been working as an overseas Filipino worker since the year 2013 until 2018, until I decided to stay in my native town in the province of Occidental Mindoro to nurture and develop my registered Private Tree Plantations of Gmelina, Mahogany, Mango and other trees. I did not stop in planting trees that reached upto forty thousand trees of Gmelina and Mahogany since 2007 to 2012, and which commenced again in 2019. This tree planting endeavor is simultaneously being performed while I conduct other livelihood business of raising hogs and chickens and palay and corn farming;
- 3. Since the year 2019, I started to reap the bounty of my hardwork. Our acquisition of land and tree planting costs were initially financed

with the help of my wife's loan proceeds being a Master Teacher in the Department of Education, and who has been teaching for twenty years now.

- 4. Aside from attending to my own registered tree plantations, I also assist other private tree plantation owners who do not have machinery and means to cut, load and transport their logs. And dealing with the Department of Environment and Natural Resources Community Environment and Natural Resources Office (DENR-CENRO) to secure necessary permits and certifications was a smooth and efficient process back then.
- 5. I was designated and have been authorized to become the "Shipper" of the Gmelina square logs harvested from the private land of Mr. Francisco Eturma of Brgy. Ligaya, Sablayan, Occidental Mindoro. Necessary documents were secured in connection therewith, among which is the Transport Certificate of Planted Trees in Private Lands, copies of which is attached herein as ANNEX A and series, and the supporting Certificate of Transport Agreement (CTA) for Gmelina square logs, copies of which is attached herein as ANNEX B and series.
- 6. I have completed previous shipments in relation to the above-mentioned planted Gmelina in the land of Mr. Eturma. On March 23, 2023, I personally went to the DENR-CENRO Office in Sablayan, together with my driver, to receive our previously applied last Shipment Permit for the logs of Mr. Eturma. Our letter request for the transport permit was received by the DENR-CENRO as early as March 17, 2023. Despite my whole day waiting in the said office, no shipment permit was released to us.
  - a. I learned on such day that CENRO Anastacio Santos was in San Jose, Occidental Mindoro for the harvest of his onions. On that morning, I was informed by Forester April Amores that CENRO Santos gave an instruction to verify from the area of Mr. Eturma if the tree stumps therein are within the area of the cutting permit. Although such instruction was indeed unreasonable for the area has been inspected for several times already, we heeded to his order, and the landowner proceeded with forest officers of DENR-CENRO.
  - b. I remained in the office waiting for the report of the DENR-CENRO forest officers in order for me to claim our Shipment Permit. They returned after 1:00 in the afternoon, they plotted that data they gathered and confirmed at around 3:00 in the afternoon that the tree stumps are within the area covered by a cutting permit. Thereafter, Forester April Amores printed the Shipment Permit and we have been asked to sign the same.

However, at 4:30 in the afternoon, I was informed that my permit was put on hold by CENRO Santos because another verification should be done, and this time, to locate the actual tree stump where each log was cut and harvested. I, as well as the forest officers, got stunned after hearing such obviously more unreasonable directive. One even uttered, "paano makukuha ang numero ng puno ay natumba at natistis na?"

- c. At that time, I once again experienced the abuse of authority and self-aggrandizement of CENRO Santos. It has been several times that he made me wait for the entire day in his office just to accomplish nothing. He would create so much issues and unverified reports just to delay my papers being processed.
- d. In utter dismay as a client, I went home to Mamburao and texted him "Public Servant Kau. Nakalagay sa pinto nyo mamamayan muna hindi mamaya na. Pakitangal ke hindi totoo, display lng. Marami ng beses na maghapon akong naghihintay sa opisina nyo." I added "Maraming shipper and naglo loading walang loading inspection, nagcucutting walang cutting permit at nagkakarga sa hindi area ng permit pero ok lang sa inyo." I informed him that "Sabi sa mga taga opisina ako lng ang ginaganito nyo. Ano ga ang kasalanan ko sa inyo." "Maraming taon din akong nagtrabaho sa CENRO pero wala akong nakitang tao na naghintay ng maghapon sa opisina, "bukod tangi sa panahon mo"". I even raised "Naka leave kayo para mag paani ng sibuyas nyo, tapos ang kliyente ay pinaghihintay nyo ng maghapon sa wala. Ang galing nyo din naman ano?"
- e. Before reading his reply to me, I received a phone call from him using his mobile number +639178387544 at 9:21 in the evening throwing me invectives: "gago ka", "punyeta ka", "putang ina mo", "animal ka", "sira-ulo", "tang-ina ka", "bastos ka" "duwag ka" "bakla ka", "letse ka" and what is worse is the malicious imputation against my person by saying "magnanakaw". Other words conveying threat was also mentioned "wag ako! Hindi mo ako kilala!" "Kami daw ng dating CENRO, Quebec ang sumisira ng kanilang mga ano. Na si Capiral daw ang tumira ng inventory, na kaya daw nya inipit ipit at itinapon ang mga taong nakikinabang sa akin ay kaparehas ko daw na magnanakaw". He insisted further that I cannot have a total of sixty thousand bd.ft. for a 284 pieces of logs. His accusations are without basis and outside of the numbers provided for in our permits and certifications in the name of Mr. Eturma. All these abusive and insulting words were within the hearing of my wife and minor son. Attached herein is a printout of my phone call history marked as ANNEX C.

- f. On March 29, 2023, at 8:30 in the morning, CENRO already denied calling me "magnanakaw" and even challenged me to file a case against him during the meeting with co-shippers. CENRO even instigated other shippers to sue me for discussing the irregularities in the loading inspection and area of loading.
- g. Attached as ANNEX D in this complaint is the transcription of our phone call conversation being heard by my wife and son.
- h. Such malicious imputations, insulting and abusive language demean my worth as a man doing merely a lawful business. Also, I was humiliated being called "magnanakaw" and "bakla" with all the intents to defame me. It likewise caused fear on the part of my family after hearing "Wag ako" "Hindi mo ako kilala", and we experienced sleepless nights and anxiety. We have been being treated unfairly. Was it because I did not comply to his demand through Mr. Tony Ungria to deliver in his favor wide Gmelina planks with 6ft. long for CENRO's sofa and tables?
- i. What is more, CENRO Santos has been accusing me of harvesting and cutting Gmelina trees allegedly planted under the DENR's National Greening Program (NGP), yet this remained unproven. He visited my log farm with his attempt to search for undocumented trees, but he found nothing. However, what is blatant and already right before his eyes violations of others are intently being ignored, just like the furniture shops keeping specie of Narra and Mulawin. He signs a transport permit even without the reporting of truck owner and driver, similar to what is being shown in this CTA marked as ANNEX E.
- j. He became used to his habit of destroying my reputation before the officers of DENR-CENRO. Yet, I have planted more or less forty thousand 40,000 trees through hard work, gave people means of employment and source of livelihood especially during the pandemic, and helped the government in its drive to have a greener environment.
- 7. With all the above allegations of material facts, Respondent has clearly showed unprofessionalism and lack of respect for his office's clients, in violation of the Code of Conduct and Ethical Standards for Public Officials and Employees (RA 6713). Thus, Respondent failed to uphold professionalism required of him as a public servant.
- 8. The Respondent failed to recognize that holding an esteemed position in the government is never a license to act capriciously with full freedom and liberty, therefore, he must be directed to conduct himself in a manner that is composed and befits a public official who

officially deals with people. Also as the saying goes, "to be worthy of respect, one must act respectably and that courtesy begets courtesy."

- 9. Indeed, the Code of Conduct and Ethical Standards for Public Officials and Employees (RA 6713) enunciates the State policy of promoting a high standard of ethics and utmost responsibility in the public service. Section 4 (c) of the said Code commands that public officials and employees shall at all times respect the rights of others, and shall refrain from doing acts contrary to law, good morals, good customs, public policy, public order, public safety and public interest.
- 10. In the light of the foregoing, Respondent Santos, by his actuation, failed to live up to such standard. Accordingly, Respondent must be held liable for Grave Misconduct, Being Notoriously Undesirable, Soliciting Gift, Failure to Process Documents within Reasonable Time and Conduct Unbecoming of a Public Official for violating the Code of Conduct and Ethical Standards for Public Officials and Employees (RA 6713).

### PRAYER

**WHEREFORE**, premises considered, it is most respectfully prayed before this Honorable Office that a judgment be rendered ordering:

- 1. Respondent Anastacio A. Santos administratively liable for **Grave Misconduct**, **Being Notoriously Undesirable**, **Soliciting Gift**, **Failure to Process Documents within Reasonable Time and Conduct Unbecoming of a Public Official**, and that the corresponding penalties be imposed upon him.
- 2. Other reliefs that this Honorable Office may deem just and equitable under the circumstances.
