

PCSD RESOLUTION NO. 23-881

"APPROVING THE PLAN OF ACTIONS ADDRESSING THE HEALTH AND ENVIRONMENTAL CONCERN OF BACUIT BAY, EL NIDO, PALAWAN AND ENJOINING THE LOCAL GOVERNMENT OF EL NIDO TO COORDINATE WITH THE PALAWAN COUNCIL FOR SUSTAINABLE DEVELOPMENT STAFF, THE PROVINCIAL GOVERNMENT OF PALAWAN AND OTHER NATIONAL GOVERNMENT AGENCIES FOR THE IMPLEMENTATION AND ACCOMPLISHMENT OF THE ACTIVITIES AND ACTION ITEMS IN THE PLAN"

WHEREAS, Republic Act No. 7611, otherwise known as the Strategic Environmental Plan (SEP) for Palawan, took effect on 19 June 1992, and Section 6 of which provides that the SEP shall serve as the framework to guide the government agencies concerned in the formulation of plans, programs and projects affecting the environment and natural resources of Palawan;

WHEREAS, Section 16 of the same law provides that the governance, implementation and policy direction of the SEP shall be exercised by the Palawan Council for Sustainable Development (PCSD);

Vision: Palawan, an innovative and dynamic global center of sustainable development

Mission: PCSDS as the driver of environmental conservation and inclusive development in Palawan, a biosphere reserve and science-for-sustainability site, guided by the Strategic Environmental Plan

WHEREAS, Sections 7 to 11 of the said Act provides for the establishment of an Environmentally Critical Areas Network (ECAN), the main strategy of SEP, which is a graded system of protection and development control over the whole of Palawan, including its tribal lands, forests, mines, agricultural areas, settlement areas, small islands, mangroves, coral reefs, seagrass beds and the surrounding sea;

WHEREAS, under Section 8 of R.A. No.7611, among the main components covered by the ECAN is the coastal/marine area which includes the whole coastline up to the open sea and characterized by active fisheries and tourism activities;

WHEREAS, Section 10 of R.A. No. 7611 provides that the underlying management philosophy of the coastal/marine zone shall be the equitable access to the resource and management responsibility by the local community;

WHEREAS, based on recent water quality studies conducted in the coastal areas of El Nido, several sources of drinking water (i.e., shallow and deep wells), and facilities and establishments (i.e., water providers, water refilling stations, tourism establishments), an alarming rate of high concentration of Coliform bacteria were found;

WHEREAS, Coliform bacteria are organisms that are present in the environment and in the feces of all warm-blooded animals and humans, which links the results of the study to the fecal waste management in the Municipality of El Nido;

WHEREAS, part of the Philippine Development Plan for 2023-2028 is to reinvigorate services, which includes a strategy to improve local tourism governance by transforming local government units (LGUs) into destination management organizations with strong private sector partnership;

WHEREAS, to implement the strategy, LGUs, with assistance from the Department of Tourism and the Tourism Infrastructure Enterprise Zone Authority, shall prioritize the provision of destination infrastructure (e.g., water, sanitation, solid waste management, health care facilities, renewable energy, early warning systems) to increase the carrying and adaptive capacities of destinations against future crises and climate change impact;

WHEREAS, several meetings were held between national government agencies, including the PCSD Staff, and the local government units of El Nido and the Provincial Government of Palawan to develop a comprehensive plan of action to address the current environmental and health concerns in the Municipality of El Nido;

WHEREAS, during the 299th regular meeting of the PCSD, the Updated Plan of Actions Addressing the Health and Environmental Health Concerns of Bacuit Bay, El Nido, Palawan, as consolidated by the PCSD Staff, was presented to the Council; 

WHEREAS, under Section 5 of RA No. 7611, the SEP shall have as its general philosophy the sustainable development of Palawan, which is the improvement in the quality of life of its people in the present and future generations through the use of complementary activities of development and conservation that protect life-support ecosystem and rehabilitate exploited areas to allow upcoming generations to sustain development growth;

WHEREAS, Section 19 of the same Act empowers the Council to formulate plans and policies as may be necessary to carry out the provisions of the SEP, as well as to adopt, amend and rescind such rules and regulations and impose penalties therefor, for the effective implementation thereof and to perform such other powers and functions as may be necessary in carrying out its functions, powers, and the provisions of the SEP law;

WHEREAS, to address the growing health and environmental concerns in El Nido and pursuant to the mandate of PCSD to ensure sustainable development in the Province of Palawan, the Council has approved the Plan of Actions Addressing the Health and Environmental Health Concerns of Bacuit Bay, El Nido, Palawan (*Annex "A"*);

WHEREAS, the effective and efficient implementation of the said action plan rests on the leadership of the Local Government of El Nido and the assistance and cooperation of other government agencies and the members of the community, especially the business and tourism sector;

NOW THEREFORE, upon motion duly seconded, the **COUNCIL RESOLVES**, as it is hereby **RESOLVED**, to approve the Plan of Actions Addressing the Health and Environmental Health Concerns of Bacuit Bay, El Nido, Palawan, attached in this Resolution as *Annex "A."*

RESOLVED FURTHER, that the Municipal Government of El Nido is enjoined to coordinate with the Palawan Council for Sustainable Development Staff, the Provincial Government of Palawan and other national government agencies for the implementation and accomplishment of the activities and action items in the plan.

RESOLVED FINALLY, that copy of this resolution shall be furnished to the Office of the Mayor of the Municipality of El Nido, the Sangguniang Bayan ng El Nido, the ECAN Board of El Nido, the Office of the Governor of the Province of Palawan and all national government offices and agencies involved.



"IMPOSING ADDITIONAL CONDITIONS TO THE SEP CLEARANCE AND ECAN ZONING CERTIFICATION OF PROJECTS LOCATED IN THE MUNICIPALITY OF EL NIDO AFFECTED BY THE IMPLEMENTATION OF THE APPROVED PLAN OF ACTIONS ADDRESSING THE HEALTH AND ENVIRONMENTAL CONCERN OF BACUIT BAY, EL NIDO, PALAWAN"

WHEREAS, Republic Act No. 7611, otherwise known as the Strategic Environmental Plan (SEP) for Palawan, took effect on 19 June 1992, and Section 6 of which provides that the SEP shall serve as the framework to guide the government agencies concerned in the formulation of plans, programs and projects affecting the environment and natural resources of Palawan;

WHEREAS, Section 16 of the same law provides that the governance, implementation and policy direction of the SEP shall be exercised by the Palawan Council for Sustainable Development (PCSD);

Vision: Palawan, an innovative and dynamic global center of sustainable development

Mission: PCSD as the driver of environmental conservation and inclusive development in Palawan, a biosphere reserve and science-for-sustainability site, guided by the Strategic Environmental Plan

WHEREAS, Sections 7 to 11 of the said Act provides for the establishment of an Environmentally Critical Areas Network (ECAN), the main strategy of SEP, which is a graded system of protection and development control over the whole of Palawan, including its tribal lands, forests, mines, agricultural areas, settlement areas, small islands, mangroves, coral reefs, seagrass beds and the surrounding sea;

WHEREAS, under Section 8 of R.A. No. 7611, among the main components covered by the ECAN is the coastal/marine area which includes the whole coastline up to the open sea and characterized by active fisheries and tourism activities;

WHEREAS, Section 10 of R.A. No. 7611 provides that the underlying management philosophy of the coastal/marine zone shall be the equitable access to the resource and management responsibility by the local community;

WHEREAS, based on recent water quality studies conducted in the coastal areas of El Nido, several sources of drinking water (i.e., shallow and deep wells), and facilities and establishments (i.e., water providers, water refilling stations, tourism establishments), an alarming rate of high concentration of Coliform bacteria were found;

WHEREAS, Coliform bacteria are organisms that are present in the environment and in the feces of all warm-blooded animals and humans, which links the results of the study to the fecal waste management in the Municipality of El Nido;

WHEREAS, part of the Philippine Development Plan for 2023-2028 is to reinvigorate services, which includes a strategy to improve local tourism governance by transforming local government units (LGUs) into destination management organizations with strong private sector partnership;

WHEREAS, to implement the strategy, LGUs, with assistance from the Department of Tourism and the Tourism Infrastructure Enterprise Zone Authority, shall prioritize the provision of destination infrastructure (e.g., water, sanitation, solid waste management, health care facilities, renewable energy, early warning systems) to increase the carrying and adaptive capacities of destinations against future crises and climate change impact;

WHEREAS, several meetings were held between national government agencies, including the PCSD Staff, and the local government units of El Nido and the Provincial Government of Palawan to develop a comprehensive plan of action to address the current environmental and health concerns in the Municipality of El Nido; ✓

WHEREAS, during the 299th regular meeting of the PCSD, the Updated Plan of Actions Addressing the Health and Environmental Health Concerns of Bacuit Bay, El Nido, Palawan, as consolidated by the PCSD Staff, was presented to the Council;

WHEREAS, under Section 5 of RA No. 7611, the SEP shall have as its general philosophy the sustainable development of Palawan, which is the improvement in the quality of life of its people in the present and future generations through the use of complementary

activities of development and conservation that protect life-support ecosystem and rehabilitate exploited areas to allow upcoming generations to sustain development growth;

WHEREAS, Section 19 of the same Act empowers the Council to formulate plans and policies as may be necessary to carry out the provisions of the SEP, as well as to adopt, amend and rescind such rules and regulations and impose penalties therefor, for the effective implementation thereof and to perform such other powers and functions as may be necessary in carrying out its functions, powers, and the provisions of the SEP law;

WHEREAS, to address the growing health and environmental concerns in El Nido and pursuant to the mandate of PCSD to ensure sustainable development in the Province of Palawan, the Council has approved the Plan of Actions Addressing the Health and Environmental Health Concerns of Bacuit Bay, El Nido, Palawan (*Annex "A"*);

WHEREAS, the effective and efficient implementation of the said action plan rests on the leadership of the Local Government of El Nido and the assistance and cooperation of other government agencies and the members of the community, especially the business and tourism sector;

WHEREAS, under the approved plan of action, the imposition of additional conditions in the SEP Clearance of all affected projects in El Nido is necessary to effectively achieve the objective of rehabilitating El Nido and to mitigate the hazards of the poor water quality in the municipality;

NOW THEREFORE, upon motion duly seconded, the **COUNCIL RESOLVES**, as it is hereby **RESOLVED**, to amend all existing SEP Clearance for projects located in the Municipality of El Nido affected by the implementation of the approved Plan of Actions Addressing the Health and Environmental Health Concerns of Bacuit Bay, El Nido, Palawan, to impose the following additional conditions:

1. Conduct water quality testing of domestic water sources within ninety (90) days from the issuance of this Resolution, and every quarter thereafter;
2. Ensure that the result of the water quality test is within the existing standards required by the government, as set by the Department of Health and the Department of Environment and Natural Resources;
3. Ensure connection to the Municipal Sewage Treatment Plant (STP) or construction of own STP within six (6) months from the issuance of this Resolution;
4. For proponents who constructed their own STP, conduct a test of wastewater discharge from the STP within ninety (90) days from the issuance of this Resolution, and every quarter thereafter;
5. Non-compliance to the above conditions shall be a ground for the suspension or cancellation of the SEP Clearance or ECAN Zoning Certification and/or imposition of One Hundred Thousand Pesos (Php100,000.00) for Category A projects, Fifty Thousand Pesos (Php50,000.00) for Category B and Category D projects and Twenty Thousand Pesos (Php20,000.00) for Category C project.

RESOLVED FURTHER, that the PCSD Staff is instructed to serve notices to the proponents of all projects affected by the imposition of additional conditions as approved in this Resolution.

RESOLVED FINALLY, that copy of this resolution shall be furnished to the Office of the Mayor of the Municipality of El Nido, the Sangguniang Bayan ng El Nido, the ECAN Board of El Nido, the Office of the Governor of the Province of Palawan and all national government offices and agencies involved.
