### **MOTION**

Comes now unto this honorable office of President Marcos and DENR Secretary Yulo-Loyzaga respectfully filed this Motion for valid reasons to wit:

That August month was the period of Barangay hearing in which attended by the following: DENR officer Gervacio, representative of the DENR; Barangay Treasurer Niño, who complained; Barangay Kagawad Nonoy Sarito; Barangay Captain Diolito Gallano who presided the hearing; and Joebeth Condes representing our Condes group of family and Domingo Condes heirs resort. The DENR explained carefully and seriously that the Domingo Condes title covered the court undergoing gymnasium construction and the residence residing on the seashore. Must moveout as soon as possible contrary to laws of DENR, Niño Sanches did not present any documents.


Office of the Mayor hearing was secondly done and was clear to everybody who publicly attended the hearing. The following attended the hearing Vice Mayor Ceann Punzalan; Municipal legal adviser Joyce Candelario; DENR officer Gerbacio; Municipal Assessor who advised to have a relocation survey; and Joebeth Condes representing our Condes group. Attached copy of the documents of prima facie evidence submitted to you for your guidance and Barangay Captain Summon on August 1, 2022 barangay hearing.


Suggestions and recommendation to solve this DENR seashore crisis the local government code has the residence allocation budget. There are already people residing willing to evacuate in the seashore once our Condes heirs shall give them memorandum but we ask from your honorable office that you would be the one to release the memorandum since you belong to the national government side it is your duty as public servant under constitution to help the complainant Domingo Condes heirs to achieve justice system as far as the law is concerned in the Marcos administration attached copy of our tax declaration and title of Domingo Condes.

Therefore, premises considered that this motion be granted and be given due course that DENR shall implement policy and laws to provide justice system to the complainants Domingo heirs. Attached are copy of Certification of Tourism (Annex A) that our seashore is certified as our tourism project, Tax declaration of Marcelo/Domingo and Notice of Barangay Captain (Annex B and C) and Certification title of Marcelo/Domingo Condes (Annex D).

We request that this seashore case shall be closed as soon as possible because we already have public hearing on the area of Sta. Fe attended by the Municipal Officials, Barangay officials, and Sanchez Family docketed already in the Sta Fe government province of Romblon. Certified by Hon. Ninoy B. Defiño and Joebeth Condes on 2nd of August 2022 at Sta. Fe, Romblon.
