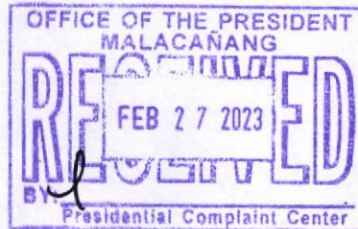

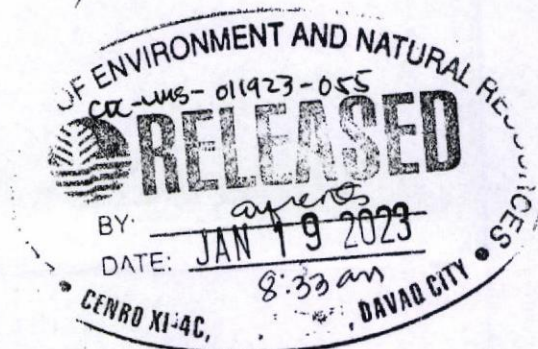

Environmental greetings!

This pertains to your letter addressed to the President of the Republic of the Philippines Ferdinand R. Marcos, Jr., praying to uphold the intention of former DENR Secretary Angelo Reyes to cancel all documents in relation to OCT 5609. Further, in a separate letter addressed to the Regional Executive Director, DENR RXI, Lanang, Davao City, you also requested for legal assistance or legal services to prove that the area you claimed is outside the jurisdiction of Ecoland Properties Development.

Relative thereto, please be informed that the July 13, 2007 decision rendered by DENR Secretary Angelo Reyes was superseded by the May 19, 2010, decision of DENR Acting Secretary Horacio Ramos. Therefore, we cannot rule on your request on upholding the decision of 2007 decision of late DENR Secretary Angelo Reyes because it is procedural in nature and involves question of law.

Your requests on upholding the 2007 decision of DENR Secretary Angelo Reyes and request for legal assistance are legal in nature and not within the ambit of authority of this Office (DENR-CENRO, Davao City). Thus, we will indorse this matter to our Regional Office, DENR RXI, Lanang, Davao City, for evaluation and resolution.
