This pertains to the Memorandum dated July 03, 2023 of OIC Assistant Secretary for Field Operations Western Mindanao, and Director, in concurrent capacity Arleigh J. Adorable, CESO IV requesting this office to submit the Work and Financial Plan with justification for the maintenance and protection of Narra Seed Production Area (SPA) located at So Igsuso, Brgy. Tubili, Paluan, Occidental Mindoro.

Since seed is considered as the basic unit of reproduction, the need of establishment of seed sources arises. Establishment of quality seed sources is the heart of any seed certification program. Seed sources from the foundation with which all aspects of seed certification resolve. It is generally recognized that quality seeds can only come from stands (natural or artificial) which are regarded to be genotypically superior. Any seed certification scheme, therefore, should recognize the necessity of establishing and/or delineating stands whose individual trees have undergone or are being considered for genetic testing, to establish their superiority over all others

With the existing policy to use only seeds from identified seed sources, selection of Indicvidual "PLUS" Trees (IPTs) from the identified seed stands (natural or plantation stands) and conversion/ establishment to a Seed Production Areas (SPA) was implemented for the NGP and for other future rehabilitation and restoration programs of the government.

The Narra Seed Production Area (SPA) was established on 2014 which cover an area of Fifty (50) hectares located at Sitio Igsuso, Brgy Tubili, Paluan, Occidental Mindoro which is approximately 28 kilometers from the municipality of Mamburao. It is accessible by any means of land transportation. The SPA is geographically lies at 120°30'38.28" Easting and 13°17'49.40" Northing. A total of Eight Hundred (800) Narra Individual Plus Trees within the SPA that need to manage and maintain by this office. However, there are instances that

the SPA was not monitored and patrolled by the personnel of this office due to conflict of schedule on the regular target implementation be accomplished.

Several activities for the maintenance and protection of SPA such as hiring of Science Research Assistant (SRA), laborers, Procurement of Solar Panel and Accessories, Perimeter Fencing of the SPA and silvicultural activities such as weeding, pruning, thinning, removal of debris, fireline construction, patrolling, retagging, repainting, phenological observation must needed to avoid the illegal activities and illegal squatter/settlers and in order to preserve and maintain the good quality of Individual Plus Trees (IPTs) within Narra Seed Production Area (SPA). Hence, funding for these activities are hereby requested.

Attached is the Work and Financial Plan of the activities within the Narra Seed Production Area (SPA).
