**PROTEST**

**PROTESTANTS**, pauper litigants, to this **Honorable Office**, most respectfully state that;

**PROTESTANTS**, prompted with urgency to go to no less than to this Office due to what it sees as a bias, violation and desecration of the actual possessioners right, security of tenure and deprivation of livelihood caused by invalidated documents presented by the heirs of Pedro Solis. The issue therefore qualifies as one of transcendental importance, paramount public interest, of all embracing significance to the actual possessioners, or with far reaching implication consistent with promoting the ends of substantial justice seeking the protective mantle of the Land Act. Under this situation, **PROTESTANTS** see an occasion for another possible historic first from proactive, forward looking and ever vigilant to this **Office of the Secretary** to render a decision to have further investigation as a legal remedy for the protection of right of the actual possessioners to the misidentification, mispresentation of a beneficiary which is not an actual tiller nor an actual possessioner as stated on the Land Act, but still there is an allegation from these heirs that the said subject land are

their owned property which they inherit from Pedro Solis the Respondent and most probably there was an erroneous and fraud presentation and process of documents as the number one problem most of the actual possessioners encountered nowadays.

## **I. PARTIES**

**PROTESTANTS**, all of legal ages, married, Filipino citizens and residents of Brgy. Cambunang, Bulalacao, Oriental Mindoro, Philippines where they may be served with orders, notices and other processes issued by this Honorable Office.

**PROTESTEES**, Heirs of Pedro Solis Rep. Pancho Solis, of legal age, married, Filipino citizens and a resident of Barangay San Mariano, Roxas, Oriental Mindoro, Philippines where they may be served with orders, notices and other process issued by this Honorable Office.

## **II. NATURE OF THE PETITION**

This is the petition for Cancellation of Insular Government Property Sales Application of Pedro Solis (deceased) now Rep. by Pancho Solis (Heirs of Pedro Solis) as the herein Petitioners are the actual occupants, tillers, cultivators for a long period of time and never given a chance to process their rights as the actual cultivators, possessioners since the time most of them was been being born on this area and part of their childhood as the helpers of their parents on tilling on this subject land.

This petition stemmed when Pancho Solis collect hundred of thousands of pesos from this actual tiller/farmers showing the copy of Resolution and stating that he is the landowner of the subject land.

## **III. BRIEF STATEMENT OF FACTS**

- 3.1. The subject land in 1930's was full of wild trees, and unproductive as the oldest resident, actual possessioner being stated (herein attach Brgy. Residency Certificate and occupancy within the subject land as ANNEX "A");
- 3.2. As the years pass by the area was being tilled by some of the actual possessioners as their source of living (herein attach the pictures as ANNEX "B");
- 3.3 As decades pass by some of them trying to inquire to the employees of the Municipality of Bulalacao on how to process the subject land for titling but due to lack of knowledge none of them pursue on the process;
- 3.4. Until such time come that Pancho Solis claiming the subject land and introduce himself as the owner using the Order of Finality from DENR Regional Office (Legal Division) (herein attach Order of Finality as ANNEX "C");
- 3.5. In the year of 2020, Pancho Solis appeared to the place where the subject land is located claiming as the heirs of Pedro Solis and pressured the actual tillers by collecting hundred thousands of money for the payment of his property and if

this actual tillers refused to pay Pancho Solis illegally ejected this poor farmers and as for some actual tillers afraid of losing the land they are tilling for a long time, they were forced to pay in order to remain on the land they are tilling; ( herein attach the Sinumpaang Salaysay as ANNEX " D";

- 3.6. Time came when these farmers seek for legal actions and to their dismay they did'nt get any positive result;
- 3.7. Until last August of 2022, when Maylen Q.Ordanza seek help from the from our Local Executive Hon.Engr.Mayor Ernilo C. Villas, and allowed us to search for legal documents and they where all shock to the result that the said subject land was a public land and lots of claimant try to file petition but still rejected and to our dismay Pancho Solis abused the conciousness of this poor actual tillers, abused their rights on the subject land by collecting huge of money and by telling that he is the landowner ( herein attach the letter of Honorable Mayor Engr.Ernilo C.Villas to the Office of the Secretary of DENR as ANNEX "E";
- 3.8. As we search on the Land Act, it is clearly stated that there must be an actual occupancy,cultivation,improvement of at least one fourth of the land applied for until the date of final payment is made and Pedro Solis ( deceased) Pancho Solis did'nt do such things as stated on the Land Act( herein attach the skitch plan of occupancy made by Engr.Oscar Castro as ANNEX "F";

#### **IV. ISSUES**

- 4.1. Whether or not Pedro Solis has the right to own and acquire the subject land as per his I.G.P.S.A application;
- 4.2. Whether or not the actual possessioners, tillers, cultivators has the right to be the owner of the land they are tilling for decades through whatever government program it may suitable;

#### **V. GROUNDS FOR THE CANCELLATION OF INSULAR GOVERNMENT PROPERTY SALES APPLICATION AND REVOCATION OF OREDER OF FINALITY**

- 5.1. The Insular Government Sales Application of Pedro Solis ( deceased) must be cancelled/revoke due to lot's of irregularities done by the said applicant as stated on Land Act 3038 under the provision of Act Numbered Twenty-eight and seventy four known as the Public Land Act on section 30 states;

" Before any patent is issued, the purchaser must show actual occupancy cultivation, and improvement of at least one-fourth of the land applied for until the date on which final payment is made;( as amended by section 5 of Act No.3517);

Now,as we go on the subject land ever since Pedro Solis is not occupying any parcel of the subject land they are applying of, instead they collect huge amount of money out of this subject land forcing the actual tillers,cultivators to pay as they are the owner, and this is a ground for large syndicate estafa ( Pancho Solis collect this huge amount of money because of the said Order of Finality.

## VI. AGRUMENT / DISCUSSION

- 6.1. That the assailed issuance of Order of Finality by the DENR Regional Office Legal Division is biased, without the actual ocular inspection of the documents presented, and even the actual ocular inspection to the subject land without the concern of the actual possessioners ;
- 6.2. In the instant case, however the concerned office must conduct an actual ocular inspection, must be vigilant to the documents presented and must required some other attachment just to proved that the assailed personal information was done legally or not and also to give the Petitioners to know the said proceedings for them to have an opportunity to be heard or to consciously participate therein;
- 6.3. The herein " moro-moro" proceeding has in fact ended without herein Petitioners knowledge or being announce or have a copy of the supposed Order of Finality to make the actual possessioners make an appeal;
- 6.4. Thus, the challenge posed the herein Petitioner for this Honorable Office of the **Secretary Department of Environment and Natural Resources** to form a " credible, unbiased and responsible team to conduct and required an ocular inspection in order to ferret out the truth and for the herein Petitioners and actual possessioners to proved all that the farm lot they actually occupy and through out their lives they develop was fraudly claim and announce that was owned by Respondent with the accomplice of the employees of concern agency;

**Petitioners are the actual possessioners were deprived of their right to due process, hence the Order of Finality was rendered and being used such order to collect huge amount of money by the Respondent and which is not qualified as a bona fide beneficiary of the I.G.P.S.A as stated on Act 3038 and with provision on Act 2874;**

1. The fact that the Petitioners, some of them are actual possessioners since from their grandparents were not accord due process stem from the fact that the supposed Order of Finality must be through a process conduct both of CENRO and PENRO;
2. That the Petitioners was the actual possessioners and also and does not given a chance to be a deem owner of the subject land and who has have the right to have the privilege of having this title land awarded by DENR to be the legal priority beneficiaries of the subject and which should not be stripped or taken away from them without due process of law;
3. Stated otherwise, a " moro-moro" Order of Finality proceeding as an instant case was intended to deprived the Constitutional rights of the herein Petitioner and their children to be the deem owner of the property. Hence, the nullity of the said transfer logical necessity to revoke the same not only for being not in the record with the true state of the property subject matter thereof but also for being violated the right of the Petitioners and actual possessioners, herein not to be deprived their right without due process of law.

## PRAYER

**WHEREFORE**, in view the foregoing, it is respectfully prayed to this Honorable Office the following;

1. **CONDUCT** actual ocular inspection and proper field investigation to verify the actual occupants/tillers/farmers/cultivators covering Lot 478 and 479 Pls-395-D Located at Brgy.Cambunang,Bulalacao,Oriental Mindoro;
2. **GRANTING** the instant petition to cancel the I.G.P.S.A of Pedro Solis( deceased) now represented by Pancho Solis and disqualify them for presenting himself as the owner of the subject land using the Order of Finality and collect a huge amount of money and who where not an actual possessioners/tillers/ cultivator of the subject land;
3. **QUALIFYING** the herein Petitioners, **GEORGE A. BANTUGAN, JEREMIAS T. GAMO, DIONISIO S. SUDARA, ALLAN C. GARCIA, TIMOTEO P. ARANO, MAYLEN Q. ORDANZA, RENATO MAGNAYE, ROGER MAGNAYE, MARIVIC LISA FABILA** and the school site as the beneficiaries of the public land Lot No. 478 and 479 Pls-395-D;
4. **DIRECTING** the CENRO ( Roxas) and PENRO of Oriental Mindoro to cause the Cancellation / Correction of Lot Nos.478 and 479 Pls-395-D before the proper forum.

Other reliefs are just and equitable under the premises.

## RESOLUTION

Submitted for resolution before this office is the case involving the claims of the Heirs of Pedro Solis, Aquilino De Leon, Heirs of Pablo Baculinao, Jr. and the Barangay of Cambunang, Bulalacao, Oriental Mindoro over Lots Nos. 478 and 479 of Pls-395-D which is more particularly identified as the area covered by the Insular Government Property Sales Application (I.G.P.S.A.) Nos. 1604 and 1605 in the name of Pedro Solis.

Records of the case shows that Pedro Solis, now deceased, filed his Insular Government Property Sales Application (I.G.P.S.A.) on October 18, 1935 over two (2) parcels of land under his Tax Declaration No. 336 valued at P 618.36 and Tax Declaration No. 390 valued at P 1,200.00 with an approximate total area of 40,000 hectares with the following boundaries: North by Amasajo Creek; East by property of Eliseo Cabagay; South by property of Quintin B. Cay and West by the Cawacat River. The corresponding application was forwarded to the Bureau of Lands Office in Manila for further action, which up to this date has not been properly acted upon.

Prior to this application of Mr. Pedro Solis, the land in question was the subject of his occupation and cultivation starting from the year 1920 when he first set foot on the same. The same records reveal that the area was first utilized by the claimant as grazing land and subsequently planted to with some seasonal crops and other plants. Such possession and occupation of the land by Pedro Solis was temporarily stopped when the same was forfeited by the Commonwealth of the Philippines by virtue of a Writ of Execution over the area as a consequence of a Penalty imposed

upon Pedro Solis in a Court Case filed against him in Criminal Case No. 2057 for illegal possession of dynamite sometime in 1935.

The forfeiture of the land subject of the writ made the same private property of the Commonwealth of the Philippines, disposable only through Sales or Lease to qualified persons as provided for under Act No. 3038. It is for this reason and his desire to have the land back in his possession that Mr. Pedro Solis filed his I.G.P.S.A. application over the above-mentioned parcels of land.

Having paid for and perfected his application on November 5, 1936 in the Manila Office of the Bureau of Lands the same was given due course. Thus, on December 7, 1936, the Director of Lands directed the District Land Officer of Calapan, Oriental Mindoro to conduct a preliminary investigation of the land covered by the described application. The desired report of investigation can not be submitted on time for reason that during all those times a number of claims over the same area were received by the District Office which needed immediate resolution. Thus on June 30, 1940, the District Land Office of Calapan, Oriental Mindoro forwarded to the Director of Lands in Manila the investigation report of Junior Public Land Inspector Indalencio Nable Jose who recommended forward action on the same.

From 1940 to October 6, 1950 no concrete development were recorded in connection with the case, save for the constant follow-ups of the applicant of his claims to which the Chief, Public Lands Division replied with an Order for him to apply for an I.G.P.S.A., a thing that he has already long complied with, and for the local lands office to investigate and appraise.

The land in question was not without any other problem during the years that followed while the same was pending in the lands offices concerned. There were a number of claims that cropped out like the claims of the Heirs of Agapito Boyo which was resolved amicably as per the Order issued November 26, 1937. There was also the claim of Vicente Magallanes, the resolution of which was contained in a similar Order dated June 30, 1940. In May 1, 1956 the most controversial problem of them all that came across this particular land came about when Mr. Pedro Solis wrote a letter to then President Ramon Magsaysay about the intrusion into his land of one Antonio Mallen. He reported that the said fellow has introduced some improvements therein and that he has also Tax Declared the same in his own name. The question, however, was resolved by the withdrawal of Antonio Mallen of his claim in an affidavit dated April 27, 1959 he executed for the purpose. An Order was likewise issued on January 19, 1961 deciding the issues and clearing the claim of Pedro Solis with regards that of Antonio Mallen. It is worthy to note, that in this series of problems that beset the claim of Pedro Solis, all the Orders issued in connection with these cases are one in saying that the IGPSA of Pedro Solis can be given further due course.

On April 4, 1963, the Chief, Legal Division informed the Chief, Land Management Division by way of a letter that the Orders dated June 30, 1940 and January 19, 1961 giving due course to the IGPSA application No. 1604 of Pedro Solis over lands at Cawacat, Bulalacao, Oriental Mindoro had become final and executory. A series of follow-ups made by the claimant, as well as, letters from the Bureau of Lands in Manila to the Calapan Office and vice versa were recorded during the the period. Thus, on July 24, 1967, the Chief, Legal Division once again, wrote a letter addressed to the Chief, Land Management Division reiterating the finality and executory nature of the two (2) above-mentioned previous Orders and further giving due course to the application of Pedro Solis.

Giving due course to the application, a request for investigation and appraisal of the land in question was made and on September 26, 1968, Land Investigator Damaso G. Evora submitted his report on the matter. The corresponding assessment of the area was also made by the Municipal Treasurer of San Pedro (now Bulalacao) Consorcio Z. Amparo. Mr. Pedro Solis was advised to pay the assessed value of P 630.00 and the provisional permit fee of P 20.00, both of which he complied with as evidenced by the Official Receipts Nos. 911408 dated November 5, 1968 and 632573 dated March 8, 1969, respectively.

Mr. Pedro Solis, the original applicant and claimant under IGPSA Nos. 1604 and 1605 died in 1974 due to old age without seeing the light, so to speak of his above application.

For quite sometime the representatives of the claimant have been following-up the case, which up to now has not yet been finally decided. Thus, on November 11, 1976, the Chief, Claims and Conflict Section of the Bureau of Lands in Manila wrote a letter addressed to the District Land Officer of Roxas, Oriental Mindoro to conduct further investigation on the subject matter to ascertain the true and correct facts obtaining in the premises due to the conflicting reports and recommendations already submitted.

And for the nth time the District Land Officer of Roxas, Oriental Mindoro requested for certified copies of the the records of the case from the Bureau of Lands Office in Manila on March 18, 1976 and August 27, 1977 to which the Chief of the Records Division willingly responded to in March 3, 1977. During the interregnum, no action was forthcoming however, because on May 16, 1991 after constant follow-ups by the Heirs of Pedro Solis and after the lapse of about two (2) decades, again the CENR Office of Roxas, Oriental Mindoro requested for certified copies of the very same records already forwarded to the local office in the above-noted case. Two (2) days earlier a Protest was submitted by the residents of Cambunang, Bulalacao, Oriental Mindoro, represented here by Leopoldo Panum, Renato De Guzman, Serapio Galos and Romualdez Cabrillos, against the Application for Free Patent of Aquilino De Leon and Pedro Solis under FPA-III-12-106, Lot No. 479, Pls-395-D and FPA-9-2588, Lot No. 478, Pls-395-D, respectively.

The investigation of the case was assigned to Hearing Officer Leon A. Abad of the CENR Office at Roxas, Oriental Mindoro. Investigation and hearing were made and set immediately with all the parties properly represented. An ocular inspection of the subject area was also made on August 17, 1991. Land Management Officer III/Hearing Officer Leon A. Abad submitted his report on October 7, 1991, which was also forwarded to the regional office for proper evaluation and appropriate action.

The significance of a final resolution of this particular case can not be over emphasized because of the length of time that it took for this question to finally reach its conclusion. Half of a century in the waiting is no joke especially if one who ardously waged battle to claim and possess the subject land is not fortunate enough to see its conclusive end. Death has intervened in the meantime, during the pendency of this case and no amount of worldly restitution is better than to put to rest the whole proceedings as do the original parties of this case in their own respective graves.

Going over the records of this case will reveal that this has dragged on for years due to the indecisiveness of those tasked to act on the same. It is also clear that other claimants and pretenders to the land were the ones who benefited and were given the better attention which resulted in the diminution of the original total area of the subject land. The question now, is however, not the old issues attached to the original claim, but rather new and collateral in nature. To be resolved now is the claims of the Sangguniang Bayan of Cambunang, the claims of Aquilino De Leon and that of Pablo Baculinao which are all opposed to the I.G.P.S.A. Nos. 1604 and 1605 of, now deceased, Pedro Solis, which was filed in October 10, 1936 over an area of over 40 hectares.

The actual resolution of this case is not at all that difficult as the issues can be limited to only two (2); First, in the issue of whether or not Pedro Solis has the right to own and acquire the land as per his I.G.P.S.A. application, and Second, whether the alleged transfers of the subject land that took place valid and with force and effect or not. The answers to these two issues will definitely resolve the other collateral issues currently besetting the case.

Going over the documentary evidences of the parties submitted to substantiate their respective claims we came upon three particular papers worth discussing in this case. Foremost of these documents is the alleged "Affidavit of Quitclaim" dated February 15, 1975 executed by Claimant Pedro Solis in favor of Antonio Mallen, his ertswhile adversary in this case. Another is the submitted "Deed of Absolute Sale" dated March 4, 1975 executed by Antonio Mallen in favor of Pablo F. Baculinao, Jr. which was sanctioned and ratified in the same instrument by Claimant Pedro Solis. The "Contract to Divide Lot No. 479, Pls-395-D", by and between Claimant Pedro Solis and Claimant Aquilino De Leon dated August 18 1975 is also cited here. The significance of these three "Deeds" can

not be overlooked as they represent the very source of all the so called series of transfers from which the rights of the other claimant emanates. The efficacy and/or validity of these conveyances will undoubtedly bear upon the ultimate of the rights of the parties in this case. Taking this as a basis for the resolution of the case is a sound judgment considering that it will determine once and for all the respective rights of the parties. The question that may be asked therefore is whether or not the above-mentioned Deeds were all validly executed and thus have force and effect. To this we answer in the negative as the records will show that Claimant Pedro Solis met his demise sometime in 1974, while the above Deeds were all executed and perfected in the year 1975. It is out of this world to have the dead rise from the grave to sign and execute an instrument against his own interest. It is also said that the dead tell no lies and this particular case is a classic example.

The mother instruments having been discredited and declared as not competent as evidence the subsidiary and subsequent Deeds emanating from these originals will therefore surely fail and suffer the stigma of doubt. Questioned documents have no place in this proceedings as they prove nothing but the futility of the case being pursued by the proponents and the resort to artificialities is the sign of resign and hopelessness. Worth mentioning is the disregard of the technicalities of the law with regards to the execution and recording of the instruments in the Notarial Books of the Notaries in this case.

With the issues of the alleged conveyances made in favor of the other parties to the case cleared and resolved, we now move on to the other issue of the present claim by the Barangay of Cambunang. Priority is the issue to be addressed in this particular aspect of the case as the claim of the Barangay is a new and recent addition to the already ages old case of the 1930's. The resolution of the IGPSA issue must first be made before any question on new issue can be tackled. The claim that the needs of the Barangay takes precedent over that of the private interest of the claimant is not well placed as there is nothing to talk about had the present case been earlier resolved and terminated. The only reason why the Barangay was able to come into the picture is the case took over half a century to decide. The Barangay using its public personality is now trying to impose its will upon the rights of private persons long denied in the process. The respect of private rights must be upheld and protected with no less than the State and its instrumentalities taking the lead.


SKETCH SUBDIVISION PLAN


