At nagsimula na rin ang Calmla at marami pang kumpanya ng minahan na gustong sumira at kalbuhin ang likas na yaman ng aming bayan. Kami po ay nanawagan at humingi ng tulong sa inyong tanggapan upang mabigyang pansin ang aming hinaing. Ninais naming mapatigil ng lubusan ang pagmimina sa aming bayan. Apektado na po ang aming kabuhayan. Labis na kaming nahirapan sa aming mga pananim at halos wala na kaming aanihin. Sana po ay dinggin na po ninyo ang aking hinaing na ito na ipatigil na sana ang ginagawang pagbubungkal ng lupa at ang pagpuputol ng libo libong higanting puno.
