SUBJECT : **REQUEST FOR HIRING OF ONE (1) DATA ENCODER (CONTRACT OF SERVICE) FROM JULY TO DECEMBER, CY 2023**

In order to support the management, operation and maintenance of the Enhanced Forestry Information System (eFIS) at the DENR-PENRO Marinduque for July to December, Calendar Year 2023, the hiring of One (1) Data Encoder (Contract of Service) from July 01, 2023 to December 31, 2023 under Formulation and Monitoring of ENR Sector Policies, Plans, Programs and Projects of Support to Operations is deemed and earnestly necessary. The said hiring is based on the approved CY 2023 Work and Financial Plan (WFP).

The Data Encoder shall perform, however, not limited to the duties and functions as follows:

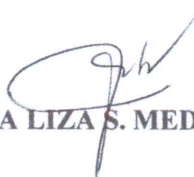
- Coordinate with the different Units of the Technical Services Division (TSD) for the preparation and update of the e-FIS records/datasets using the e-FIS Manual Data Entry (MDE) Forms for each of the applicable e-FIS modules;
- Ensure that the e-FIS Manual Data Entry (MDE) Forms are updated, completely and correctly filled-out, with supporting documents such as copy of Agreement/Certification and maps;
- Facilitate the regular forestry data collection, preparation and update of MDE Forms with supporting documents such as copy of Agreement/Certification and maps from the different Units of the Technical Services Division (TSD), and the update, assessment, validation and proper online transmission of the e-FIS databases to the Regional Office;
- Ensure that all data from the MDE Forms including the supporting documents such as copy of Agreement/Certification and maps are encoded, uploaded in the e-FIS and submitted to Regional Office;
- Prepare and submit monthly and quarterly reports to the PENR Officer on the status of the implementation of the e-FIS;
- Provide feedback on the management and maintenance of the e-FIS; and
- Perform all other related functions as may be assigned from time to time.
