Kami pong mga katutubong Mangyan ng Silangang Mindoro na mga nagsasaka ng abaka sa kabundukan ng Mindoro ay nagbuo ng isang kooperatiba. Ang Mangyan na Nagsisikap sa Gawang Yamang Maasahan Agriculture Cooperative (**MANGYANMANACO**) ay may kasapiang pawang mga katutubong Mangyan na ang karamihan ay naninirahan sa liblib at kabundukan. Ito po ang mga lugar na may malalayong lakin, walang kalsada at lalong walang ilaw. Nakakalat po kami sa apat (4) na tribo at walong (8) bayan ng Silangang Mindoro. Nagkaisa kaming pag-ibayuhin ng lakas ang pag-aabaka ng katulad naming mahihirap alang alang sa aming pamilya at kinabukasan. Kami po ay mga nag-aabaka na noon pa man ngunit nais po naming mapauunlad pa ito sa susunod na mga taon. Sa gayon, makaakit kami sa mga kapwa katutubo na unti-unting maiwasan ang pagkakaingin at pag-uuling ngunit may magandang kinikita para sa pamilya.

Kaugnay po nito, lumalapit kami sa inyo upang humingi ng tulong para matustusan ang pagpapatanim ng 1,403 ektarya ayon sa plano ng mga kasapi. Ito po ay karagdagan sa kasalukuyang naani naming 32 tonelada kada taon. Sa amin pong pagtataya, may kabuuang 72,600 ang magagastos ng isang magsasaka hanggang sa unang pag-ani ng isang ektarya. Ang abaka po ay sadyang napakainam tumubo, may matagal na pakikinabang ng mga pamilyang katutubong Mangyan. Ang pagtulong po ninyo sa amin ay pag-abot sa mamamayang nasa kalibliban totoong nasa kalibliban at napapag-iwanan sa larangan ng pag-unlad.



II. BACKGROUND/RATIONALE

Mangyan is one among 110 Ethnolinguistic groups in the country. They are the original inhabitants of Mindoro Island that exist even before the time of colonization. Divided unto seven (7) sub tribes cross wide of the island, known as Hanunuo, Buhid, Bangon, Tawbuwid, Tadyawan, Alangan and Iraya to the northern part of the island. Majority of these communities are not even accessible to farm to market roads, that's why the transportation of produce farm products contributes to general concerns. Numbers of hours for hiking to reach the farm locations or even some communities. Distance, no roads, weather conditions are some factors to look for. Generally, they are surely below poverty line, 4Ps members but not yet all are included because of distances of the communities.

Practicing traditional farming such as kaingin or slash burning methods is general practice too among IPs as annual activity of each household. This is usually short-term root crops for family consumption within a year. But the majority are leaning on planting roots and even high values crops. It can be found in their farm lands even now. Abaca is one among others. The condition of soil, availability of market and moist climate almost provincewide of Oriental Mindoro are contributing factors why abaca is one the most promising source of income.

As of now, IP abaca farmers that member in cooperatives are capable to harvest up to 35,779 kilos from 115, 242 number of plants. Some of them are fully rely on this crop as source of income to expense even the schooling of their sibling. This year, 2023 to 2028, 1, 403 hectares are planned to be plant by cooperative members.

The Mangyan na Nagsisikap sa Gawang Yamang Maasahan Agriculture Cooperative (**MANGYANMANACO**) was newly organized, purely first Mangyan cooperative that the main purpose is to serve as a link of transformation among IP members/communities in term of socio-economic aspect. Thru this, even in the most distant communities are attended for available services. As no such cooperative among IPs exist before for abaca and related to farming. The area of operations is all over the province, especially those IPs of four (4) tribes such as Tadyawan, Tawbuwid, Iraya and Alangan, abaca farmers and IP farm lovers.

III. OBJECTIVES

This project is aim to enhance and facilitates the expansion of abaca planting activities. Expansion, because of even as present, IPs are continuously planting and harvesting abaca in their localities. The other objectives are mention below:

- 1) Ensure the facilitation of planting activities in 14 clusters from 8 Municipalities of Oriental Mindoro.
- 2) Ensure the smooth communication among all abaca IP planters even in the most remote areas in the mountain that usually left behind.
- 3) Increase cooperation, eagerness and nature loving thru abaca farming than practicing annual kaingin practices among fellow IPs.
