



- 20 % discount in fare for domestic air, see travel and public land transportation

596 discount in basic necessities and prime commodities

340 discount in basic necessaries and praise continuous which are entitled
 1296 VAT-exemption on the purchase of goods & services which are entitled to the 20 % discount

• 5% discount for the monthly utilization of water and electricity, provided that the water and electricity meter bases are under the name of the senior citizens Persons and Corporations violating RA 9994 shall be penalized. Only for the exclusive use of Senior Citizens: abuse of privileges is punishable by taw.
