

Please be informed that on 03 August 2023, the Office of the Solicitor General (OSG) received a copy of the Petition for Writ of *Kalikasan* dated 27 July 2023. Attached is a copy of said petition, for your reference.<sup>1</sup>

Although the Supreme Court has not yet directed the public respondents to file the appropriate responsive pleading to the Petition for Writ of Kalikasan, we believe that it will be forthcoming very soon. Thus, we deem it prudent to coordinate with your good office this early to allow us more time to study, strategize and prepare the necessary pleading that will be required of us by the Supreme Court. As you may well know, the periods prescribed under the Rules on Environmental Cases are quite restrictive, thus the need to prepare this early on.

In this regard, may we request the DENR to provide the OSG copies of the following documents:

- 1. Case Briefer (procedural and factual antecedents);
- 2. Pertinent DENR/MGB issuances, orders or similar documents;
- 3. Judicial Affidavits of potential witness;
- 4. Reports pertaining to the issues raised in the petition;
- An outline (in relation to item 1) with admissions and denials on the allegations in the petition and arguments in support of the government's position in this case; and
- 6. Other such documents that my aid us in drafting the required comment or Return of the Writ.
