

COMPLAINT AFFIDAVIT

Macalintal with address at Brgy. 9, Mamburao, Occidental Mindoro and Nancy Alcantara, with address at Brgy. Alacaak, Sta. Cruz Occidental Mindoro, of violation of Section 77 of Presidential Decree (PD) 705 also known as "Forestry Reform Code of the Philippines, as amended," committed as follows, to wit:

That on or about May 6, 2023, at about 4:00 o'clock in the afternoon, Sitio Tilago, Brgy. Kurtinganan, Municipality of Sta. Cruz, Occidental Mindoro, Philippines, both accused Proceso B. Macalintal and Nancy Alcantara with intent to gain, did then and there willfully, unlawfully, and feloniously have in their possession and transported lumber by means of dump truck, 142 pieces of Gmelina lumber with an appropriate volume of 2,561.89 board feet amounting to One Hundred Twenty-Seven Thousand Four Hundred Sixty-Four and 58/100 (P127,464.58) without any permit, authority and legal document from the Department of Environment and Natural Resources (DENR) violating Section 77 of Presidential Decree (PD) 705 also known as "Forestry Reform Code of the Philippines, as amended."

Custodio, with address at Mamburao, Occidental Mindoro, of violation of Section 77 of Presidential Decree (PD) 705 also known as "Forestry Reform Code of the Philippines, as amended," committed as follows, to wit:

That on or about May 27, 2023, at about 8.00 o'clock in the morning, Sitio Igsusu, Brgy. Tubili, Municipality of Paluan, Occidental Mindoro, Philippines, the said accused Eric Christian D. Custodio, with intent to gain, did then and there willfully, unlawfully, and feloniously have in his possession, custody and control two (2) pieces of special cut and design of lumber breakdown and classified as one (1) Dungon lumber (10 in" x 9 in" x 52 ft") and one (1) Guijo lumber (8 in" x 9 in" x 52 ft") (dipterocarp species) with an appropriate volume of more or less Seven Hundred Two (702) board feet amounting to Two Hundred Thousand Pesos (\$\frac{1}{2}\$200,000.00) without any permit, authority and legal documents from the Department of Environment and Natural Resources (DENR), violating Section 77 of Presidential Decree (PD) 705 also known as "Forestry Reform Code of the Philippines, as amended."
