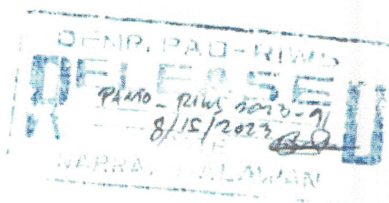


In compliance with the verbal instruction of the PENRO Puerto Princesa City re: Letter of the "KASAREGAN IT MASIKAMPO" Mr. Joel Limsa of Tagbanua Tribal Organization of Narra, Palawan re: suruguiden or hearing on the complaint of their IP members a certain Charmelito Batac and Wilfredo Batac. Pleased be informed that before the start of the hearing the presiding officer Mr. Joel Limsa informed that they cannot recognized any participants who has no official authority in accordance with their "customary Law" accordingly, We explained that their letter was received last Friday August 8, 2023 a very short period of time to inform our PAMB chairman to attend the scheduled meeting.

The secretary of the kasaregan it Masicampo Ms. Analyn Lumagdong read and recap the minutes of the previous hearing conducted last August 4, 2023 which she mentioned the complaint of Mr. Charmelito and Wilfredo Batac on the non-compliance to their customary laws, having No Free Prior and Informed Consent (FPIC), construction of Wardens camp, Bird watch tower, Board walk, installation of camera trap, and Marking of Bacauan (BAMS monitoring stations).

Due to no official authorization letter issued to us by our office to present to the Kasaregan it masikampo the maradya did not recognized our presence as guest and observer and explained that this activity is not just a simple meeting but rather a hearing/paglilitis (suruguiden). Further, the kasaregan it masikampo asked for the pleasure of the body wherein they agreed to send again another invitation to the KFI and PAMB for the postponed hearing schedule on august 24, 2023.
