OMNIBUS ORDER

In a Resolution dated June 13, 2023, this Court resolved to deny the Application for Writ of Preliminary Injunction prayed for by the Plaintiffs. The Status Quo Ante order issued in open court on March 22, 2023 was also lifted.

On July 12, 2023, the Court is in receipt of a Motion for Reconsideration assailing the above Resolution. In an Order dated July 17, 2023, parties were given ten (10) days to submit any comment or opposition to the motion for reconsideration. Continuation of the hearing was scheduled on September 21, 2023.

Then the Court received on July 31, 2023, a Motion for Leave of Court to Intervene as Plaintiff, along with a Complaint-in-Intervention from the Provincial Government of Palawan. On even date, this Court received a Comment/Opposition to the Plaintiff's Motion for Reconsideration, from the Philippines Reclamation

Authority. Also on July 31, 2023, the Court is in receipt of Defendant's Roberto Magallanes and Jose B. Magallanes Jr.'s Comment/Opposition.

On August 4, 2023, Court is in receipt of a Manifestation and Submission filed by plaintiffs BCT Trading and Construction and 428 Hi-Tech Group, Inc., praying that the attached documents therein be considered in the Court's resolution of its Motion for Reconsideration.

WHEREFORE, premises considered, the Court hereby resolves to:

1. Grant the **LEAVE OF COURT** to file a Motion for Intervention as Plaintiff filed by the Provincial Government of Palawan.

2. Considering that the **MOTION TO INTERVENE** itself is a litigious motion, hearing on the same is hereby set on the next scheduled hearing, originally set on **SEPTEMBER 21, 2023 at 8:30 in the morning**.

3. In view of the pending Motion for Intervention and it appearing that the issues raised by the original plaintiffs are adopted by the Provincial Government of Palawan, making their issues necessarily intertwined, the hearing on the Motion for Reconsideration filed by the plaintiffs on the June 13, 2023 Resolution, is hereby set on the same date of **SEPTEMBER 21, 2023 at 8:30 in the morning**.
