House Bill No. 6641

"AN ACT PROVIDING FOR A FREE AND CULTURE-SENSITIVE CIVIL **REGISTRATION FOR INDIGENOUS PEOPLES"** Introduced by Rep. Rufus B. Rodriguez; and

3. House Bill No. 3340

"AN ACT ESTABLISHING A SYSTEM PROTECTING THE COMMUNITY INTELLECTUAL RIGHTS OF INDIGENOUS CULTURAL COMMUNITIES/INDIGENOUS PEOPLES" Introduced by Rep. Maximo. Y. Dalog, Jr.
