Dear Mr. Elefane :

This refers to the letter dated April 26, 2018 about your concern on the alleged violation of Rio Tuba Nickel Mining Corporation in the issued ECC condition under item no. 34 of ECC -CO-9612-008-302 that states " the proponent shall immediately execute a Perpetual Lease Agreement and/or Lease Agreement with the landowner of the 7km. Macadam Road linking the quarry areas and the pier sites".

In our initial investigation of the issue, it appears that the area that you are referring to has already been purchased by the mining company and has long been acted upon by the concerned authorities as manifested in the documents provided by the RTN mining company, such as :

- a) Court Order of the RTC of Puerto Princesa City, Palawan, Branch 46 issued dated December 1988;
- b) Deed of Absolute Sale;
- c) Deed of Assignment;
- d) Waiver of Rights;
- e) Right of Way Agreement; and
- f) Other pertinent documents in favor of the company

Further, in view of the project expansion of the company, a new ECC was issued to them per ECC-CO-1312-OO43 dated March 09, 2015 that supersedes the previous ECC as indicated above issued to RTN mining company.

However, you may provide also this Office any additional supporting documents of your claim over the issue at hand that may form part of our further investigation and action, as necessary.





This is in response to your letter, dated and received by this Office on 02 September 2019, requesting for assistance with your standing concern on the alleged violation of Rio Tuba Nickel Mining Corporation (RTNMC) with the issued Environmental Compliance Certificate (ECC) docketed under ECC – CO - 9612 - 008 - 302, specifically condition Item No. 34 stating that:

"The proponent shall immediately execute a Perpetual Lease Agreement and/or Lease Agreement with the landowners of the 7-km Macadam Road linking the quarry areas and the pier facilities."

In consonance to your previous letter dated 23 August 2019 requesting for the issuance of a document supporting your claim that there was no legal acquisition that transpired further demanding the concerned mining company to pay all the damages caused and related to this issue, we are reiterating the Order of the Regional Trial Court of Palawan and Puerto Princesa City given on December 1988 for the Civil Case No. 861 for Road Right of Way, which we believe we had already provided you with a copy, stating that:

Recoved: 09/25/19 BILVIC. ELEFANE

"...this case has long been terminated and the decision in this case long been final and executory. Considering the instant motion to be well-taken and meritorious, as prayed for, the defendants, their heirs, assigns, and successors – in – interests are hereby enjoined and/or restrained from blocking and closing any portion of the road right of way and/or in any manner doing any act that would be inimical to the plaintiff and/or impede the peaceful and continuous operation of the plaintiff's mining business in Rio Tuba, Bataraza, Palawan, in order to maintain the status quo."

Additionally, with regard to the circumstance of the new ECC denominated under ECC – CO -1312-0043 superseding the formerly issued compliance certificate, the appropriate authority to provide you the necessary discussion would be the EMB Regional Office or EMB Central Office. Thus, this Office does not have the legal personality to issue any document related to the ECC without the consent and/or approval of EMB Regional/Central Office. Consequently,

please be informed that we had referred this matter to the above-cited government units for their respective actions.

Lastly, you may refer to the matrix provided for the details of the actions taken by this Office based on the compiled documents from the Environmental Management Bureau – Provincial Environment Management Unit of Puerto Princesa (EMB – PEMU Puerto Princesa).
