IAC RESOLUTION 04 - 2022

A RESOLUTION CONFIRMING THE PREQUALIFIED PROPONENTS OF RIVER RESTORATION, THROUGH LARGE SCALE DREDGING ACTIVITIES, IN ORIENTAL MINDORO, AS OF DECEMBER 06, 2022

WHEREAS, Section 5.4 of DENR-DPWH-DILG-DOTr Joint Memorandum Circular No. 01, Series of 2019 provides for the "Guidelines on the Issuance of Clearance and/or Permit for Dredging Within Waterways or other Inland Bodies of Water" where the issuance of the dredging permit/clearance by the DPWH shall be based on the Detailed Engineering Design Plans.

WHEREAS, DENR Department Administrative Order No. 14, Series of 2019 provides that the Inter-Agency Committee (IAC) shall propose policies and programs for rationalize the dredging operations in the Province of Oriental Mindoro.

WHEREAS, the IAC held a meeting on 06 December 2022 at the DENR MIMAROPA and approved the documents submitted by pre-qualified proponents upon endorsement of the Technical Working and Financial Working Groups for River Restoration and Dredging Activities.

WHEREAS, upon motion of Mines and Geosciences Bureau Region IV – B MIMAROPA Regional Director Glenn Marcelo C. Noble, duly seconded by Department of Public Works and Highways Region IV – B MIMAROPA Regional Director Gerald A. Pacanan, the IAC approved the instant Resolution.

NOW THEREFORE, BE IT RESOLVED, that the following proponents are pre-qualified to undertake River Restoration thru Large-Scale dredging activities in the following river systems:
