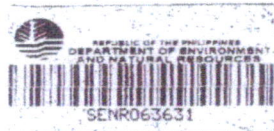

CONSULTATION WORKSHOP FOR THE FINALIZATION OF THE DRAFT LOGICAL FRAMEWORK AND PROGRAM/PROJECT IMPLEMENTATION PLAN OF FORESTRY INVESTMENT ROADMAP

Activity Design
December 1-2, 2022

I. RATIONALE

It is the strategy of the government, through the Department of Environment and Natural Resources (DENR), to recognize the indispensable role of the private sector, encourage private enterprise, and provide incentives to needed investments under the purview of sustainable forest management that promote the development of efficient, globally competitive, climate resilient and environmentally friendly forest-based industries to boost inclusive growth and rural development. Hence, the DENR, through the Forest Management Bureau (FMB), has formulated several policies with the end in view of encouraging the private sector to invest in the development of identified potential investment categories within the forest lands, in order to increase the GDP contribution of the forestry sector to the national economy without adversely affecting the ecological integrity of our watersheds and forestlands.

One of the policies issued by the Department is DENR Administrative Order No. 2019-22, entitled "Adoption of the Forestry Investment Road Map (FIRM)". The FIRM is an avenue for enabling and capital investments towards the development of the forests through local and foreign direct investments that will consequently increase the forestry's contribution to the Philippines' GDP. The implementation of the FIRM will have short-term, medium-term, and long-term targets.

In order to properly implement and monitor the progress of the FIRM, it is imperative that logical framework and project implementation plan be developed as these will outline the requisite steps for the facilitation and execution of the indicated strategies including timeline and list of needed resources. Further, it is necessary that consultation with selected DENR Regions be conducted to gauge the applicability of the activities in the field level and to resolve possible gaps in its implementation. Hence, the conduct of this *Consultation Workshop for the Finalization of the Draft Logical Framework and Program/Project Implementation Plan of Forestry Investment Roadmap* is imperative.

II. OBJECTIVES

1. Solicit inputs/comments on the draft Logical Framework and Project/Program Implementation Plan of the Forestry Investment Road Map;
2. Gauge the applicability of the stipulated activities of the FIRM in the field level;
3. Resolve possible gaps on its implementation; and
4. Finalize the Logical Framework and Project/Program Implementation Plan of the Forestry Investment Road Map (FIRM).

III. METHODOLOGY

The activity shall consist of consultation and sharing of experiences via face to face with FMB and DENR Regional representatives who have already been involved in the implementation of Forestry Investment Road Map (FIRM).

The consultation shall be through presentation of the draft logical framework and program/project implementation plan. Simultaneous solicitation of inputs, recommendations and/or clarifications shall be conducted.

The regional participants are expected to bring the following information:

- 1) Activities conducted by the Region in support to the implementation of DAO 2019-22; and
- 2) Comments and recommendations on the implementation of the FIRM.

IV. EXPECTED OUTPUT

At the end of the activity, the participants are expected to provide inputs in the development and finalization of the draft FIRM Logical Framework and PIP, and come-up with ways forward and necessary policy recommendations and enhancements.

V. PARTICIPANTS/SCHEDULE/VENUE

The consultation workshop will be participated by personnel from DENR Regional Offices of Regions III, IV-A, and MIMAROPA who are involved in the implementation of Forestry Investment Road Map (FIRM) on December 1-2, 2022 in Region IV-A.

VI. RESOURCE PERSONS/SECRETARIAT

Selected Forestry Investment Development Division (FIDD), Forest Management Bureau (FMB) technical staff shall serve as resource persons for the activity. Likewise, the Forest Investment Packaging Section, FIDD of FMB shall be in-charge of the documentation and other logistical and administrative support for the workshop.

VII. BUDGETARY REQUIREMENTS

The activity shall entail an estimated cost of PhP135,000.00 for meals and accommodation and other expenses broken down as follows:
