Please be informed that the undersigned has been performing the duties and responsibilities as OIC-CENRO of Puerto Princesa since June 15, 2021. However until today I have not received my Representation and Transportation Allowance (RATA) due to the absence of affirmation of my RSO by the office of the Secretary or its authorized representatives.

The following are the circumstances of my designation as OIC-CENRO of Puerto Princesa.

June 15, 2021 – RSO No. 330 Series of 2021 designating the undersigned as In-Charge, CENRO Puerto Princesa City, Palawan to ensure continuity of operations and delivery of services while OIC-CENRO Felizardo B. Cayatoc is on rehabilitation leave due to COVID 19. The order also states that it is automatically revoked upon the return of OIC-CENRO Felizardo B. Cayatoc.

CENRO Cayatoc reported back to duty as OIC-CENRO of Puerto Princesa on August 16, 2021, hence RSO No. 330 is deemed automatically revoked.

January 7, 2022, then OIC-CENRO Felizardo B. Cayatoc was designated as OIC-PENRO of Palawan and eventually got promoted to the position. After his re-assignment to PENRO Palawan, I again assumed as OIC-CENRO of Puerto Princesa City until to date.

June 21, 2022 – Special Order No. 2022-484 signed by Acting Secretary Jim O. Sampulna CESO I re: Affirmation of Regional Special Order No. 330 issued to DMO IV Pedro A. Velasco as Officer- In-Charge (OIC) CENR Officer of CENRO Puerto Princesa City, Palawan, DENR Region 4B.

In view of the above circumstances, the following questions need to be resolved to allow me to receive my RATA.



In response to your memorandum dated 31 January 2022 on the above-captioned subject, please be informed that pursuant to the Manual of Authorities on Human Resources Development and Administrative Matters (DAO 2014-03), specifically on designation of PENR and CENR Officers for above 30 days, and up to 30 days, the authority rests to the Secretary of the Department and the Undersecretary for Field Operations, respectively.

Considering that there was no Special Order issued by the DENR Central Office designating the CENR Officer, Puerto Princesa City, it is the opinion of the undersigned that the pertinent provisions of Republic Act No. 7613, otherwise known as the Code of Conduct and Ethical Standards for Public Officials and Employees, particularly Section 5 (c) thereof shall apply, viz:

Section 5. Duties of Public Officials and Employees. - In the performance of their duties, all public officials and employees are under obligation to:

(c) Process documents and papers expeditiously. - All official papers and documents must be processed and completed within a reasonable time from the preparation thereof and must contain, as far as practicable, not more than three (3) signatories therein. In the absence of duly authorized signatories, the official next-in-rank or officer in charge shall sign for and in their behalf.

Furthermore, Item (1) of Section 5, Rule VI of the Implementing Rules and Regulations (IRR) of R.A. No. 6713 states that, "If there is only one official next-in-rank, he shall be automatically the signatory."

Foregoing considered, the holder of the next-in-rank item to the CENRO, Puerto Princesa City shall perform the duties and functions of the CENRO Puerto Princesa City.

This has reference to the designation of Officer-In-Charge of CENRO-Puerto Princesa City.

Please be informed that upon the designation of the undersigned as the OIC-PENRO of Palawan, there was no Special Order issued as replacement of the CENR Officer of Puerto Princesa. That pursuant to the Manual of Authorities on Human Resources Development and Administrative Matters (DAO 2014-03), the authority to designate the PENR and CENR Officers for above 30 days, and up to 30 days, rests to the Secretary of the DENR and USEC for field Operations respectively. However, there was no Special Order issued designating the CENR Officer of Puerto Princesa.

In this case, the OIC-Regional Executive Director in memorandum dated February 11, 2022 (copy hereto attached), rendered her opinion citing pertinent provision of Republic Act 6713, otherwise known as the Code of Conduct and Ethical Standards for Public Officials and Employees, particularly Section 5(c).

Section 5. Duties of Public Officials and Employees. - In the performance of their duties, all public officials and employees are under obligation to:

(c) Process documents and papers expeditiously. - All official papers and Documents must be processed and completed within a reasonable time from the Preparation thereof and must contain, as far as practicable, not more than three (3) signatories therein. In the absence of duly authorized signatories, the official Next in rank or officer in charge shall sign for and in their behalf.

Moreover, Item (1) of Section 5, Rule VI of the Implementing Rules and Regulations (IRR) of R.A. 6713 states that, "If there is only one official next-in-rank, he shall be automatically the signatory."

In view of the foregoing, and considering that DMOIV Pedro A. Velasco was reassigned from CENRO Coron to CENRO Puerto Princesa by virtue of Regional Special Order No. 390, dated September 15, 2021(copy of RSO attached), now referred as the holder of the next-in-rank, he shall therefore be required to immediately assume the responsibility as Officer-in-Charge of CENRO Puerto Princesa, and inform the Regional Executive Director thru this office in writing, of his compliance for information and record purposes. and record purposes.
