Evident burned plastics and other garbage as well as the rotted nylons, woods, and plastic with used oil observed during the conduct of clean-up at Reclamation Area is noteworthy and must be address thus, it is recommended that the BLGU and LGU should formulate and strictly implement an ordinance/policy on solid waste control with corresponding fines for those boat owners who will not abide as well as the establishment of monitoring station in the area as one strategic intervention.

**CELEBRATION OF ZERO WASTE MONTH CY 2023** 

In celebration of this year Zero Waste Month with theme: "Stepping up Solid Waste Management through Efficient Extended Producer's Responsibility" this office have conducted ground improvement within office premises of CENRO Coron.

On January 27, 2023 ground improvement was successfully done in participation of 26 personnel of CENRO Coron composed of 11 males and 15 females. The collected waste was leaf litter and fallen branches from trees surrounding the office and was properly discarded.

Moreover, DENR CENRO Coron actively participated in the conduct of simultaneous coastal clean-up on January 28, 2023 at Reclamation Area of Brgys. Poblacion 3 and 5, Coron, Palawan. Said activity was hosted by Solid Waste Management Office of Local Government Unit (LGU) of Coron, Palawan in observance to the above mentioned celebration.

Approximately 41 sacks of garbage mostly consist of fishing lines, plastics, bottles, rag clothes and woods were collected by more or less 200 individuals from Barangay LGU, LGU-Coron, Department Social Work Development (DSWD), 4P's, Philippine National Police (PNP) and DENR

An informal interview with 20 random participants was conducted during the activity to determine the significance of the intervention. Based on the interview, most garbage came from tourist boat operators and irresponsible individuals who threw their trash anywhere. Burned plastics and other garbage was evident in the area. Rotted nylons, woods, and plastic with used oil was also observed obviously from the boats docking in the area.

Thus, formulation and strictly implementation of ordinance/policy of BLGU and LGU for solid waste control with corresponding fines for those boat owners who will not abide as well as establishment of monitoring station in the area is highly recommended as one strategic intervention to address the issue on solid waste management.
