In preparation for the CY 2024 Budget Call of the Congress and to improve the CBFM-CARP planning and budgeting, the DENR Regional Offices and field offices are being requested to submit their CY 2024 CBFM-CARP Project Proposals for Agroforestry and Livelihood Projects and/or Projects under Financial Assistance/Subsidy to POs to support their current livelihood/enterprises through provision of tools and equipment.

The submission of project proposals emanating from the CBFM-POs was one of the agreements during the CY 2022 CBFM-CARP Annual Implementation Review Workshop conducted on 5-9 December 2022. The submitted project proposals shall be reviewed starting February 2023 by the composite team from the Community Forestry Section (CFS), Forest Resources Management Division of this Office and from DENR CARP National Coordinating Office based on the CBFM-CARP Project Implementation Guide. The Capsule Project Proposals shall be written based on the prescribed format per existing guidelines, with the following attachments:

1. Work and Financial Plan (WFP) showing the details of the proposed project, including the assumptions used;
2. Planting design/scheme of the proposed area for development;
3. Map showing the relative location of the proposed area for development within the CBFMA area and its geotagged panoramic view; and
4. PO resolution expressing their commitment to implement and sustain the Project;

Relative thereto, please submit the CY 2024 CBFM-CARP project proposals **not later than 15 March 2023** following the above documentary requirements. Please be reminded that the budget of the Region under CBFM-CARP shall be based on your submitted proposals.

Hence, lack or late submission of project proposals may greatly affect your CY 2024 CBFM-CARP funds. Please coordinate with Community Forestry Section of the Forest Resources Management Division for more details. You may submit advance copy of the project proposals through email at frmd.cfs@fmb.denr.gov.ph or to your respective CFS Focal Person.
