As previously discussed with Ms. Christine from Surveys and Mappings Department through phone, I am attaching Document No. 2023-0388 from DENR-PENRO Palawan and other relevant documents regarding the Survey Authority request of the Philippine Reclamation Authority dated November 16, 2022 (which was 98 days ago). These documents are related to the Municipal Government of Taytay, Palawan's effort to resolve issues with the reclamation area in Barangay Poblacion, Taytay, Palawan, by following the guidelines provided in PRA-AO-2021-01, specifically Section 7.

As a brief background, I contacted DENR CENRO Taytay this morning (February 22, 2023) to follow up on the request, and was informed that they plan to resubmit the request to PENRO and clarify that it should be forwarded to the regional office. However, when I spoke to PENRO to seek clarification, I was informed that there is no need to reiterate the request, and that they stand by their initial decision to return the request to the CENRO level, as they are the proper authority to issue the SA under DAO 2022-10.

Obtaining the requested SA is crucial for the Municipal Government to fully comply with Section 7 of PRA AO 2021-01, as it requires the forfeiture of the concerned area in favor of the government and its subsequent conveyance to another government instrumentality. However, it is concerning that the processing time for this document within the government agency has taken longer than expected, in contravention of the Anti-Red Tape Act (ARTA) provision that mandates the timely processing of documents. As the Municipal Government and the government agency are both part of the same entity, it is essential that we work together to expedite the processing of this document. As such, I am seeking assistance to resolve this issue promptly.

The Municipal Government of Taytay, Palawan, represented by the undersigned, would greatly appreciate immediate action on this request to expedite other processes related to PRA forfeiture proceedings. Your prompt attention to this matter is much appreciated. Thank you.


