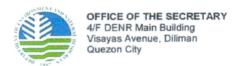

Management Letter on the
Comprehensive Compliance Audit on the

by the Department of Environment and Natural Resources (DENR)
from 2011-2016 and 2017-2021

Pursuant to Section 2, Article IX-D of the Constitution of the Philippines and Section 43 of the Government Auditing Code of the Philippines (PD 1445), we have conducted a Comprehensive Compliance Audit on the National Greening Program (NGP) to look into the compliance with Section 2 of Executive Order (E.O.) No. 26, series of 2011 of the Department of Environment and Natural Resources (DENR)¹ through DA-DENR-DAR convergence initiative, as mandated under paragraph 2.6 of E.O. No. 23.

The audit specifically looked into the adequacy and propriety of the program's legal and policy framework and the alignment of the existing policies with the provisions of E.O. No. 26 for NGP and E.O. No. 193 for Enhanced NGP (ENGP); and the compliance with related laws, rules and regulations affecting the implementation of the NGP by the DENR Central Office (CO), Bureaus, Regional Offices (ROs) and the Provincial Environment and Natural Resources Offices (PENROs) during the period 2011-2016 for NGP and 2017-2021 for ENGP, respectively.

Specifically, the audit aimed to: (a) evaluate the extent of compliance by the DENR with Section 2 of E.O. No. 26 and the availability of the performance measurement system to measure achievement of the NGP's objectives (Sec. 1); (b) determine the adequacy and propriety of the NGP and ENGP policies and the alignment of said policies with the provisions of E.O. Nos. 26 and 193, respectively; (c) establish the validity of all transactions relating to NGP and ENGP; d) assess the extent of compliance with applicable laws, rules and regulations in the implementation of NGP and ENGP at the DENR's CO, Bureaus, ROs and PENROs; and (e) recommend measures to enhance the existing policies and procedures to improve future NGP implementations.

Sec. 4, E.O. 26

The compliance audit on NGP and ENGP was conducted in accordance with the International Standards of Supreme Audit Institution on Compliance Audit (ISSAI 4000) adopted under COA Resolution No. 2020-011 dated January 30, 2020. Those standards require that we plan and perform the audit to obtain a reasonable basis for our conclusions.

Deficiencies observed in the course of the audit were earlier communicated through Audit Observation Memoranda (AOMs) issued by the NCR Special Audit Team and the respective Regional Audit Teams, which were formally discussed with the Management of the DENR ROs and PENROs in exit conferences held on various dates. Likewise, audit findings pertaining to the legal and policy framework together with the overall audit findings were communicated to DENR Secretary.

Audit findings from all levels were integrated into the Consolidated Management Letter, which were also discussed with the DENR top officials in an exit conference held on August 18, 2022 and during a meeting with the Secretary and other DENR top Officials on January 4, 2023. All comments were incorporated in this letter, where appropriate and necessary. The results of the NGP compliance audit is presented in detail in the attached **Annex 1** of this letter.

Also, enclosed is a partially filled-up form of an Agency Action Plan, attached as **Annex 2**, for you to complete, and to return to the undersigned within 15 days from receipt hereof. The Agency Action Plan shall ensure the proper implementation of the audit recommendations by concerned DENR officials in all levels.

Likewise, a status report on the actions taken by Auditee's Management to implement the audit recommendations shall be submitted within sixty (60) days from the date of receipt hereof, pursuant to Section 97 of the General Provisions of the General Appropriations Act of 2022 (RA No. 11639). The template on the Agency Action Plan and Status of Implementations (AAPSI) is also attached as **Annex 3**.

Lastly, we extend our sincere appreciation to the Honourable Secretary and other DENR's top Officials and personnel in all levels for the cooperation and assistance that they have extended to our audit teams during the audit.
