This has reference to the letter of Assistant Secretary Joey G. Sumatra of the Department of Agrarian Reform (DAR) dated 12 January 2023 notifying the Land Management Bureau (LMB) to start with the screening and selection of personnel to be hired as Contract of Service (COS) under the SPLIT project to augment the existing DENR personnel in the verification of DAR submitted Survey Returns (SRs), given the expected volume of submission of DAR's SRs under the project.
