*A. Land Reclassification and Protected Area Bills*

1. House Bill No. 4889, entitled “An Act Reclassifying Certain Parcels Of Land Of The Public Domain Located In Barangays Iraan, Sagpangan, Isaub, Magbabadil And Cabigaan, All In The Municipality Of Aborlan In The Third District Of The Province Of Palawan As Alienable And Disposable Land Open To Disposition Of Agricultural, Residential, Commercial, Industrial And For Other Purposes”, by Rep. Edward S. Hagedorn; and
2. House Bill No. 6373, entitled “An Act Declaring The Three (3) Nautical Miles Surrounding The Kalayaan Island Group And Scarborough Shoal In The West Philippine Sea As Marine Protected Area Under Republic Act No. 7586 Or The National Integrated Protected Areas System Act Of 1992, As Amended By Republic Act No. 11038, Or The Expanded National Integrated Protected Areas System Act Of 2018” by Rep. Edward S. Hagedorn.

We would like to request the submission of your position paper on the aforementioned topics, or a draft thereof, on or before **19 January 2023 (Thursday)**, in order to give the Committee Members enough time to read through the materials.
