## **Salient Points:**

- 1. The House Bill aims to establish the 3 nautical mile belt of sea surrounding *all* the maritime features in the Municipality of Kalayaan and the Bajo de Masinloc (aka Scarborough Shoal) that generate a baseline as per RA 9522 as Marine Protected Areas under the NIPAS.
- 2. The House Bill also aims to establish a PAMB and PAMO for this MPA.

## Comments:

- 1. The House Bill does not specifically define or enclose the identified area to be established as NIPAS MPAs; further, the Bajo de Masinloc (located in offshore Zambales) and KIG are not contiguous with one another.
- 2. The House Bill does not identify an MPA category.
- 3. The House Bill must align with the Arbitral Award.
- 4. The proposed MPAs of the DENR must further be considered and discussed.

#### Recommendations/Actions:

- 1. Provide Cong. Hagedorn the background of DENR initiatives in declaring MPAs in the West Philippine Sea.
- 2. Present to Cong. Hagedorn the DENR proposed MPAs, and the results of the PASA
