## ORDER

Moreover, in open court, the defendant undertake to shoulder the transportation expenses of Mr. Felizardo Cayatoc in going to and from the Municipal Trial Court of El Nido, on his scheduled hearing.

Set the continuation of Presentation of Defendant's Evidence on January 12, 2023 at 8:30 in the morning and 2:00 o'clock in the  $\mu$ 

afternoon, on January 13, 2023 at 8:30 in the morning and on January 26 and 27, 2023 both at 8:30 in the morning and 2:00 o'clock in the afternoon as agreed by the parties.
