In reference to the Audit Engagement Planning of the Operations Audit Division (OAD), the following Audit Areas to be prioritized for CY 2023-2025 are as follows; (1) Enhanced National Greening Program (E-NGP); (2) Tenurial Instruments (Forestry Sector and Protected Areas); and (3) Land Management.

- 10. Other Lawful Purposes Lease Agreement (OPLA)
- 11. Tree Farm Lease Agreement (TFLA)
- 12. Agroforestry Farm Lease Agreement (AFFLA)
- 13. Special Use Agreement in Protected Areas (SAPA)
