Guidelines for the RDC Budget Review and Endorsement of the FY 2024 Agency Budget Proposals

I. Background/ Legal Basis

In one of the provisions of Executive Order 325, s. 1996, the Regional Development Councils are mandated to review and endorse to the national government the annual budgets of agency regional offices (AROs), state universities and colleges (SUCs), and special development authorities.

RDC review of the annual budget proposals aims to ensure that the programs, activities, and projects (PAPs) proposed by AROs, SUCs, and other government bodies are consistent with the regional development plan and investment program.

On 12 January 2023, DBM issued National Budget Memorandum (NBM) No. 145 or the National Budget Call, which signals the preparatory stage for the National Expenditure Program (NEP) for FY 2024. The National Budget Call requests all heads of the departments, agencies, bureaus, offices, commissions, state universities and colleges, and other government instrumentalities to prepare their budget proposals for FY 2024. Among others, NBM No. 145 requires the agency budget proposals must do the following:

- a. Respond to the expected continuing headwinds brought about by the Russia-Ukraine war, the external recessionary pressures which inflation has stoked and the economic scarring which COVID-19 has wrought to our economy;
- b. Implement risk-managed interventions in areas of food security, transport and logistics, energy, bureaucratic efficiency and fiscal management, health, education, and social protection, to ensure the unimpeded and adequate delivery of social services, mitigate inflation pressures, accelerate economic recovery, and address economic scarring; and,
- c. Ensure that only implementation-ready agency proposals are included. The government will also look into the agencies' previous year budget utilization and performance as part of its evaluation process.

Further, strategic regional needs shall still be prioritized while harmonizing regional plans with national priorities in order to enhance linkages to achieve equitable regional investment opportunities and growth. The FY 2024 budget shall provide funds for agencies' regional programs, which are responsive to the needs of the poorest, disadvantaged, and lagging LGUs. AROs shall coordinate their efforts with the MIMAROPA RDC and provide

timely feedback to ensure convergence of regional programs. They are also expected to consult with their provincial counterparts/offices and/or LGUs, congressional districts, and SUCs to assess the complementation of projects in the localities. Moreover, the proposals of the SUCs should be endorsed by their respective Board of Regents, Board of Trustees, or other approving bodies.

II. Expenditure Management Framework

The FY 2024 budget proposals shall incorporate the following:

- a. Priorities and policy directions of the Marcos Jr. Administration as embodied in the 8-point Socioeconomic Agenda and the Philippine Development Plan (PDP) 2023-2028 including programs which support the achievement of the targets set in the Administration's Medium Term Fiscal Framework;
- b. Continuing emphasis on infrastructure development, including the Build Better More program as well as digital and social infrastructure; and,
- c. Provision of funds for capacity-building programs for LGUs to enable them to assume the devolved functions and services.

III. Purpose

The guidelines for the RDC budget review and endorsement for FY 2024 agency budget proposals aims to:

- a. ensure that the proposed development programs, activities, and projects (PAPs) for FY 2024 of AROs, GOCCs, and SUCs are consistent with the Regional Development Investment Program (RDIP) 2023-2028, MIMAROPA Regional Development Plan (RDP) 2023-2028;
- b. Facilitate submission, sectoral committee consultation and review, and RDC endorsement of the FY 2024 budget proposals of AROs, SUCs, and other government bodies; and,
- c. provide the schedule of activities to ensure timely submission and review of the budget proposals by the MIMAROPA RDC.

IV. General Guidelines

a. The FY 2024 budget proposals shall reflect the continued adoption of the administrative reforms provided in Section 2.3 of NBM No. 145.

- b. Both proposed Tier 1 and Tier 2 projects shall consider the following concerns of the region:
 - PAPs identified under the MIMAROA Regional Development Plan 2023-2028 and Luzon Spatial and Infrastructure Development Framework;
 - PAPs identified under the Master Plan for Sustainable Urban Infrastructure Development in Calapan City;
 - Priority infrastructure PAPs across all sectors which can be sourced from the FY 2024 Annual Investment Program (AIP), Three Year Rolling Infrastructure Program (TRIP) 2024-2026, and those PAPs approved by the RDC through a resolution;
 - PAPs relative to the implementation of the proposed Regional Government Center;
 - PAPs relative to climate-change adaptation or mitigation;
 - PAPs in support of the implementation of the Executive Order No. 138, series of 2021, "Full Devolution of Certain Functions of the Executive Branch to Local Governments, Creation of a Committee on Devolution, and for other purposes", particularly capacity building programs for LGUs, subsidies for local projects of LGUs belonging to the 5th and 6th income classes, the GIDAs, as well as those with the highest poverty incidences, ranked in top third highest; and,
 - PAPs for gender and development (GAD) adopting the new guidelines of the Philippine Commission on Women (PCW) stating that the determination of compliance to the GAD budget floor shall be by agency and not by constituent unit (e.g., regional offices, district or field offices) and that the agency as a whole shall meet the minimum 5% GAD budget based on the agency's total appropriations;

V. Mechanics of the RDC Budget Review and Consultation

- a. The RDC will conduct a budget forum on 02 February 2023 to discuss the National Budget Call and the mechanics of the RDC budget review and consultation. The Forum shall be participated by the representatives of the regional line agencies, state universities and colleges, and private sector representatives, and the local government units.
- b. The RDC FY 2024 budget review shall be conducted on 21-24 February 2023 during the sectoral committee (SecCom) meetings (refer to schedule of activities). Regional Directors (RDs)/ Assistant Regional Directors (ARDs) and heads of other agencies shall present their respective FY 2024 budget proposals.

In the absence of the head of agency, the designated representative may present the budget proposal provided that

an authorization letter duly signed by the head of agency will be submitted to the Secretariat.

- c. The following shall serve as the review panel during the FY 2024 Budget Review and Consultation:
 - Regional Director NEDA MIMAROPA
 - Assistant Regional Director NEDA MIMAROPA
 - Regional Director DBM MIMAROPA
 - District Representatives of MIMAROPA or their Chiefs of Staff
 - Provincial Governors and City Mayors of MIMAROPA
 - RDC Private Sector Representatives (PSRs)
- d. AROs, GOCCs, and SUCs shall prepare and submit to the MIMAROPA RDC SecCom Secretariats their FY 2024 budget proposals in the following prescribed format:
 - BP Form 1.1: FY 2024 Budget Proposal under Tier 1
 - BP Form 1.2: FY 2024 Budget Proposal under Tier 2
 (AROs, GOCCs, and SUCs shall rank their Tier 2 PAPs
 according to their own priorities)
 - BP Form 2: FY 2022 Budget Utilization Rate
 - BP Form 3: Status of FY 2023 RDC-endorsed Budget Proposals
- e. For RDC monitoring purposes, AROs, GOCCs, and SUCs shall provide feedback to the SecCom Secretariats on the (1) FY 2022 budget utilization rate per operating expenditure (BP Form 2) and (2) status of their FY 2023 RDC endorsed budget proposals reflecting the PAPs that were considered or not considered in the 2023 GAA (BP Form 3).
- f. All electronic copies of the RDC budget review forms indicated above shall be submitted to the MIMAROPA RDC SecCom Secretariats on or before 13 February (Monday) through the following email addresses under the subject title AGENCY NAME: FY 2024 Proposed Programs and Projects, copy furnish mimaropa@neda.gov.ph:
