HELD ON AUGUST 13, 2021, THROUGH VIDEOCONFERENCING**

RSC Resolution No. 2021-06

**AMENDING RSC RESOLUTION NO. 2019-10 SPECIFICALLY INCLUSION OF
ADDITIONAL AND RECLASSIFIED STATISTICAL INDICATORS WITH
CORRESPONDING DATA SOURCE AGENCY TO BE INCORPORATED IN THE
UPDATING OF THE REGIONAL SOCIAL AND ECONOMIC TRENDS MIMAROPA**

WHEREAS, statistics is an essential element for the formulation of sound economic development policies;

WHEREAS, the Regional Social and Economic Trends (RSET) presents time series statistical information on the social and economic environment of the region;

WHEREAS, indicators found in RSET are disaggregated in different dimensions that are useful in the conduct of strategic planning; policy, program, and project formulation; business/investment decision-making; and research and feasibility studies;

WHEREAS, the annual updating of RSET MIMAROPA is one of the priority thrusts of the Regional Statistics Committee;

WHEREAS, the Philippine Statistics Authority (PSA) MIMAROPA is designated to lead in the data compilation and production of RSET MIMAROPA, pursuant to Article 6, Rule 5, of the Philippine Statistical Act of 2013;

WHEREAS, pursuant to RSC Resolution No. 2019-10, the coordination and cooperation of RSC member agencies and other government instrumentalities including local government units are needed to ensure timely and relevant data as input to the annual updating of RSET MIMAROPA;

WHEREAS, time series data of indicators found in the Core Regional Indicators System and Core Sustainable Development Goals Indicators need to be incorporated into the RSET MIMAROPA, pursuant to RSC Resolution Nos. 2019-07 and 2019-08, respectively;

WHEREAS, recognizing data gaps and emerging issues on science, technology, and innovation statistics in the MIMAROPA Region, which is not yet a part of the existing editions of RSET MIMAROPA, it was deemed necessary to incorporate a new chapter on Science and Technology as part of the said publication beginning its 2022 edition;

NOW, THEREFORE, ON A MOTION DULY SECONDED, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to amend RSC Resolution No. 2019-10 by specifically including additional and reclassified statistical indicators with corresponding data source agency (Annex 2021-06-A) to be incorporated in the annual updating of Regional Social and Economic Trends MIMAROPA.

RESOLVED FURTHER, to request the concerned government agencies to provide necessary data support to monitor all indicators and submit the data to PSA MIMAROPA on or before June 30 of the reference year.

RESOLVED FINALLY, that copies of this resolution be furnished to all concerned agencies and offices.
