The abovementioned shall attend classes through online platforms. They are required to work in their respective offices except for one (1) day off privilege per week, starting First Semester, SY 2022-2023 to First Semester, SY 2023-2024; and two (2) days off per week for the Second Semester, SY 2023-2024.

The grantees shall receive full scholarship grant under the DENR Local Scholarship Program pursuant to the Memorandum of Agreement (MOA) between the DENR and the PUP. Further, the DENR shall continue to pay their salaries and other emoluments and adjustments, subject to the existing scholarship guidelines and the usual accounting and auditing rules and regulations.

As recipients of scholarship grant, the grantees are required to sign a Service Obligation Contract with DENR which shall serve as basis for monitoring and evaluation of performance as regards to compliance with scholarship rules and regulations.

This Order takes effect immediately and shall remain in force until completion of the said Program.
