II. PRELIMINARIES

The meeting started at around 9:35 AM with a prayer and singing of national anthem and MIMAROPA hymn through audio-visual presentation.

III. DECLARATION OF QUORUM

DMO II Estrella and PDO I Millares acknowledged the members. Of the nineteen (19) regional line agencies, thirteen (13) were in attendance, constituting a quorum of 68.42% as declared by NPC Blanco and called the meeting in order.

IV. OPENING REMARKS

RNC Chair, RD Baquilod delivered his opening message welcoming everyone. RD Baquilod shared that good reports were seen on COVID-19 data in the country and in MIMAROPA, although there are still challenges in terms of vaccination. In the last two months, there were imported cases in some areas but due to high vaccination rate, onward transmission was prevented.

Further, RD Baquilod emphasized the critical role of nutrition in terms of immune response especially this time of pandemic.

VI. HIGHLIGHTS OF THE MEETING

A. Review of Highlights of the Previous Meeting

In the interest of time and to give ample time to discuss the main agenda, Ms. Eje moved to dispense the review of the highlights of the meeting with the motion

seconded by Mr. De Ramos. NPC Blanco added that if members have additional inputs, members may email their comments until 16 September 2022.

B. Introduction of Vitamin Angels to the RNC

Dr. Luz R. Escubil, the Country Program Manager of Vitamin Angels introduce the Vitamin Angels to the RNC. The following are the information shared by Dr. Escubil during the meeting:

1. Who are the Vitamin Angels?

Vitamin Angels is a public health nonprofit working to improve nutrition worldwide with a goal to reduce inequity by ensuring that underserved, nutritionally vulnerable populations have access to evidence-based nutrition interventions.

2. What do We Do?

We partner with local organizations, including governments, to reach the most underserved, nutritionally vulnerable populations- pregnant women, infants, and children- with evidenced-based nutrition interventions.

3. What are EBNIs?

Evidenced-based Nutrition Interventions:

- Multiple Micronutrient Supplementation (MMS) for pregnant women
- Promotion of optimal maternal, infant and young child nutrition (MIYCN)
- Vitamin A Supplementation + Deworming (VAS + D)

4. Delivery of Evidence-Based Nutrition Information

- 60m hard-to-reach women and children
- 65+ countries
 - √ 50% of our reach occurs through 9 priority countries
- 2,000+ partners
 - ✓ Government (national, state, local, etc.)
 - ✓ Non-governmental organizations (INGOs, CBOs, clinics, etc.)

5. Who Qualifies to be a partner?

- Must be locally registered organization in the country of program operation
- Can reach pregnant women and/or children 6-59 months.
- Must serve individuals who do not have regular access to Vitamin A, albendazole, and/or maternal supplements (IFA or MMS) from national health services.
- Distribute Vitamin Angels' nutrition interventions without funding from Vitamin Angels.
- Serve at least 500 children 6-59 months and/or 100 pregnant women.

6. How to become a Program Partner?

Plan and Apply for a Grant

✓ After reviewing our eligibility criteria, determine the need in the communities you serve, coordinate with your government or local health center to avoid duplication, and complete our application, found here: https://www.vitaminangels.org/grant-applications.

Deliver the Interventions

✓ After your grant is approved, Vitamin Angels will send your shipment to your primary address. Integrate the nutrition interventions into your programs in a way that works for you and your community. Use the educational and training materials provided to help you distribute the interventions safely and effectively.

Report and Renew

✓ Six months after you receive the grant, we will check-in to assess your inventory and discuss any issues with the distribution. After completing the distribution, submit the Annual Reporting form. Once the annual report has been submitted, grant can be renewed annually by submitting a simple grant extension application.

- Support tools such as VAS+D visual checklist, Steps Card, instructional videos, instructor-led course slides and reference manuals

C. Introduction to Philippine Multi-Sectoral Nutrition Project

Dr. Mathew Medrano facilitated the discussion about the introduction to Philippine Multi-Sectoral Nutrition Project. Agreements and the roles and responsibility was also discussed.

- It was stated at first that the Philippine Multi-Sectoral Nutrition Project aims to support the government in adopting a bold, multi-sectoral nutrition approach to deliver a coordinated package of nutrition-specific and nutrition-sensitive interventions across various LGUS together with a harmonized social behavior change and communication strategy.
- Component 1: Enhancing Nutrition Service Delivery Through Primary Health Care Integration will be under the supervision of the DOH, it aims to focus on strengthening primary health care systems to enhance the delivery of nutrition specific and sensitive interventions, as well as the provision of Social and Behavioral Change Communication to improve key behaviors important to address stunting. The component finances Performance Based Grants (PBG) to stimulate the implementation of high impact interventions. The activities under this component can be categorized into three sub-components.
- Component 2: Community-based Nutrition Service Delivery and Multisectoral Nutrition Converge will be led by DSWD, it will focus on multisector community-based promotion of key family practices and health care seeking behaviors for improved maternal and child health and nutrition outcomes. The component supports the design and implementation of household and community level interventions to improve mother and child health and nutrition, with emphasis on the first 1,000 days of life.
- Component 3: Institutional Strengthening, Monitoring and Evaluation and Communications finance the Institutional strengthening of project implementing entities including the Local Government Units; Project Management and Monitoring and Evaluation.
- The project will prioritize LGUs with the highest burden of childhood stunting based on best available data. Primary project beneficiaries will comprise children under five years old (with attention to children under two years who will be reached by project activities before stunting becomes largely irreversible), as well as pregnant and lactating women in LGUs prioritized for PMNP support. There are 14 identified target areas in the MIMAROPA region, this includes 7 municipalities in Occidental Mindoro and 7 municipalities in Romblon.

- Dr. Mathew Medrano then discussed the roles and responsibility of the Department of Health (DOH) and the Department of Social Welfare and Development (DSWD) - as co-implementing agencies.
- He also said that the respective Regional Offices of the DOH, NNC and DSWD are mobilized to implement and coordinate technical assistance to the Project LGUs in line with the directions, policies and guidelines of their respective national offices.
- Dr. Medrano also said hat the PMNP-RTWG shall be established, chaired by the CHD Director and co-chaired by the DSWD Field Office Director. The PMNP-RTWG shall be composed of representatives from the following, but not limited to, participating agencies:

NNC - Regional Office;

DA - Regional Office; and

DILG - Regional Office.

- He also tackled and discussed the roles and responsibilities of different agencies like Department of Interior and Local Government (DILG), Department of Agriculture (DA) and from different LGUs such as from Provincial/Municipal Local Government Units (PLGUs), PHO, Provincial Nutrition Office (PNO), and Barangay Government.
- D. Presentation of the proposed PMNP RTWG Structure in MIMAROPA (Passing of RNC Resolution No. 3, s. 2022: Adopting the membership of the RNC as PMNP RTWG in MIMAROPA)

NPC Blanco facilitated the reading of the RNC Resolution No. 3, s. 2022 for the adoption of the membership of the MIMAROPA Regional Nutrition Committee (RNC) as Philippine Multisectoral Nutrition Project Regional Technical Working Group (PMNP RTWG) in MIMAROPA. After the reading, RD Baquilod called for comments from the members.

It was then agreed that the secretariat will email the resolution to all the RTWG members for comments and suggestions open until 16 September 2022 from which secretariat will revise and finalize for approval of the RNC Chair.

E. Introduction of PMNP RPMOs and RMobTAT (DOH and DSWD) to the PMNP RTWG and RNC.

Since COVID-19 situation already eased and no more strict travel restriction, onsite monitoring has been done to local government units and local nutrition focal points this year. She also discussed the schedule for the remaining MELLPI PRO evaluation that will cover all the five (5) provinces, component city, highly urbanized city.
