Happy New Year!

This refers to the invitation letter sent to Director Claudio on December 21, 2022 regarding the forest carbon inventory training originally scheduled on January 11-14, 2023.

Southern Palawan was battered with heavy rains for the past weeks brought by the northeastern monsoon and a low-pressure area (LPA) causing [severe flooding](#), especially in the town of [Brooke's Point](#) where one of our training sites is located. Portions of the national highway became impassable, bridges collapsed, and electricity and communication lines were cut-off. The municipal government of Brooke's Point placed the town in a [month-long state of calamity](#).

Due to the severity of the situation and the risks associated with pushing through with the activity, we have decided to reset the training to **February 6-12, 2023** (travel time included). Our team is currently redirecting efforts toward responding to the needs of affected partners in coordination with partner communities, LGUs, and CSOs. We will provide updates on travel arrangements in the coming days as we work through adjustments on logistics. Kindly send your assigned representative's name and contact information on or before **January 11, 2023, 4:00 PM** for us to facilitate their travel arrangements.
