SUBJECT : **REPORT ON THE VERIFICATION OF ALLEGED BLACK
SAND MINING WITHIN THE MUNICIPALITY OF BACO,
ORIENTAL MINDORO**

Forwarded is the initial of the PENRO Monitoring and Enforcement personnel on the alleged black sand mining in Brgys. San Andres (Malaylay) and Pulantubig (Mayagao) both in the Municipality of Baco, Oriental Mindoro.

Based on the report, a post from social media that a vessel was allegedly extracting sand within the said Barangays. Upon verification and coordination with concerned LGU, the said vessel, which is later identified as Yong Sheng 699 and a company identified as Birds Nest Resources Corporation. The said activity was monitored by their Bantay Dagat and according to the MENRO of Baco and Chairperson of Brgys. Pulantubig (Mayagao) and San Andres (Malaylay) they were only conducting soil sampling for the River Restoration Project. No vessel/ship were observed during the conduct of verification.

Likewise, the Provincial Government of Oriental Mindoro, specifically the Provincial Legal Office, called for a meeting on June 13, 2023 and accordingly, they had no knowledge on the said activity. The embedded personnel of the Mines and Geosciences Bureau also confirmed that they did not issue any permit on the above-mentioned corporation. Likewise, the PCG also confirmed that no entry and exit pass issued to the said vessel/ship.

Reference to the above-cited subject, please be informed that the undersigned conducted verification on the alleged black sand mining in Brgy. San Andres (Malaylay) and Brgy. Pulantubig (Mayagao) in the Municipality of Baco, Oriental Mindoro, which was posted on social media by certain "Jheng Lascana".

Actions Taken:

On June 12, 2023, the PENRO Monitoring and Enforcement Team had coordinated with the MENRO of Baco as well as the Barangay Chairperson of Brgy. Pulantubig (Mayagao), Baco, Oriental Mindoro. The Team also coordinated with the Barangay Chairperson of Brgy. San Andres (Malaylay), Baco, Oriental Mindoro, through phone call.

Findings/Observations:

Based on the coordination conducted and observation of the location of alleged black sand mining and discussion with the MENRO and the Chairperson of Brgy. Pulantubig, Baco, Oriental Mindoro, the vessel/ship identified as Yong Sheng 699 and a company identified as Birds Nest Resources Corporation only obtained sample of sand for the river restoration project of the Province of Oriental Mindoro which includes the Municipality of Baco. Likewise, no vessel/ship were observed during the conduct of verification. Accordingly, the said extraction of soil sample was monitored by the Bantay Dagat of Baco, Oriental Mindoro.

On June 13, 2023, the Provincial Government of Oriental Mindoro specifically the Provincial Legal Office (PLO) called for special meeting relative to the alleged black sand mining. Accordingly, the Provincial Government of Oriental Mindoro had no knowledge on the said activity. The embedded personnel of Mines and Geosciences Bureau (MGB) also confirmed that there was no permit issued to the above-mentioned corporation whether an Ore Transport Permit nor Exploration Permit.

The Team also secured a copy of Municipal Certification issued by Honorable Mayor Allan A. Roldan interposes no objection on the river restoration project within the Municipality of Baco. Likewise, a copy of Resolution No. 126-2023 from Office of the

Sangguniang Bayan interposing no objection on the river restoration and Resolusyon Bilang 02-2023 from the Tanggapan ng Liga ng mga Barangay ng Baco, Oriental Mindoro.

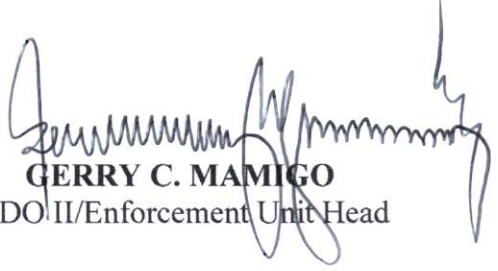
As per coordination from Philippine Coast Guard of Calapan, Oriental Mindoro the mentioned vessel has no entry and exit pass, and, they have no knowledge also of the operation.

Recommendation:

Based on the result of conducted verification, the Team recommended for continuous monitoring of the shoreline particularly in the Municipality of Baco for illegal environmental activities, and for the Mines and Geosciences Bureau (MGB) Regional Office to conduct in-depth/further investigation on the above-mentioned activity.

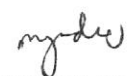

WHEREAS, a comprehensive and sustainable approach to river dredging can balance the need for economic development, ecosystem conservation, and community well being;

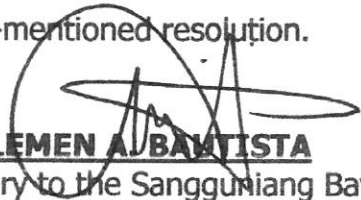
WHEREAS, the importance of sustainable river management is being recognized and acknowledge dredging as a valuable tool for maintaining healthy and functional river;
