The meeting started by a roll call and facilitated by OIC Assistant Secretary Gilbert C. Gonzales followed by a message from Undersectary Juna Miguel T. Cuna. The instructions to the Regional Executive Directors (REDs) as well as the highlights of the meeting are as follows:

## Undersecretary Juan Miguel T. Cuna

- USec Cuna reminded the REDs to submit a two-day site visit plan/iteneraries for the Secretary's consideration. Considering the bulk of the project goes to the implementation of the NGP, it was suggested to highlight successful NGP sites which are accessible in each region.
- To showcase ecotourism sites as DENR plays integral part in the ecostourism of the country in ensuring environmental protection.
- Ecostourism is one of the priorities in the 5 GEMs however Cebu is not included.
   Nevertheless, there are areas and programs in each regions that can be highlighted.
- The REDs are also reminded to have sense of urgency in submitting factual reports for the Secretary.
- To resolved/tackeled all concerns of the congressmen and local officials in preparation of the upcoming budget hearings.
