May we respectfully request for updated list on the deputized/designated WEOs and WTMUs that are manning air and/or sea ports in your respective areas of jurisdiction in consonance with Section 30 (Deputation of Wildlife Enforcement Officers) and Section 33 (Creation of Wildlife Traffic Monitoring Units) as mandated under Republic Act 9147 otherwise known as the Wildlife Resources Conservation and Protection Act. In addition to this, may we also request for the list of airports and seaports manned by the said WTMUs.

On a related matter, and in connection to the proposed amendment of the Republic Act 9147 regarding the creation of plantilla positions for wildlife law enforcement, may we also request for information on the number of personnel to be assigned as Wildlife Enforcement Officers per Region/PENRO/CENRO and the Wildlife Traffic Monitoring Units to be assigned in one (1) airport/seaport.
