



OF CENRO BROOKE'S POINT

Information, Education and Communication campaign and other activities are continuously conducted by the personnel of this office in collaboration and participation of the Local Government Units and other partner agencies and companies within the jurisdiction of the CENRO. Several activities from April to June 2023 were conducted and participated, to wit:

I. Special Events and Celebration

1. Earth Month

On April 22, 2023, CENRO Brooke's Point conducted coastal clean-up at Ursula Island Wildlife Sanctuary (UIWS). 21 participants (20 male, 1 female) from Mines and Geosciences Bureau MIMAROPA, CENRO Brooke's Point personnel and Rio Tuba Nickel Mining Corporation actively participated on the said event. Participants started by happily picking up coastal debris around UIWS. A total of 9 sacks or an estimated 50 kilos of non-biodegradable wastes were collected in the area. Most of the debris collected was food wrappers, containers, glass and plastic beverage bottles. Collected wastes were then transferred to mainland Rio Tuba for proper disposal.









2. Month of the Ocean

On May 13, 2023, CENRO Brooke's Point in collaboration with Coral Bay Nickel Corporation conducted coastal clean-up at Sitio Tagdalungon, Barangay Rio Tuba, Palawan. Over a hundred participants consists of personnel from Coral Bay Nickel Corporation, CENRO Brooke's Point, Barangay LGU of Rio Tuba and local communities actively participated on the said event. A short program was conducted first before the clean-up and mangrove planting. Participants started by happily picking up coastal debris around the area. A total of 12,000 kilos of non-biodegradable wastes were collected in the area. Most of the debris collected were food wrappers, containers, glass and plastic beverage bottles. Collected wastes were collected by the garbage truck of Coral Bay Nickel Corporation to be transferred to the Sanitary Landfill of LGU Bataraza. After the clean-up, the participants proceeded to the planting area to conduct mangrove planting. A total of 300 mangrove propagules (tangal) were planted in 0.6 hectares.



3. World Environment Day

On June 05, 2023, CENRO Brooke's Point in collaboration with Ipilan Nickel Corporation (INC) conducted tree planting at Barangay Maasin, Brooke's Point, Palawan. It was participated by 92 individuals consists of 50 INC personnel, 30 SDMP scholars and 12 CENRO Brooke's Point Personnel. A total of 11, 200 seedlings with species like Narra, Ipil, Agoho, and Bamboo were planted in a 2.2 hectares area. Photos and video with high resolution were uploaded to the google drive link provided by the Central Office per undated Memorandum. Likewise on the same date, DENR CENRO Brooke's Point personnel attended the 2023 World Environment Day Program through Zoom.

4. Arbor Day

On June 30, 2023, CENRO Brooke's Point in collaboration with Coral Bay Nickel Corporation conducted tree planting at Sitio Tamlang, Barangay Samariniana, Brooke's Point, Palawan. It was participated by 38 (16 female, 22 male) individuals consists of Barangay LGU of Samariniana, Coral Bay Nickel Corporation, Tamlang Irigators and CENRO Brooke's Point personnel. A total of 500 seedlings with species like Narra, Ipil, Kamagong, Udling, Agoho and Amugis were planted in a 0.25 hectares area.

The IEC also increases awareness of the community on the importance of the forest and its benefits in their daily lives and the effects of forest destruction/denudation including the forestry laws, rules and regulations being implemented by the DENR in the protection and conservation of our natural resources.


After each presentation, an open forum follows. Several issues and concerns arose during forum which were answered by each presentor. The following are the issues and concerns noted by the Team:

- Cutting of Trees within ancestral domain
- Constraints in the exercising/enforcement of duties and responsibilities of BLGU officials and/or DENROs relative to implementation of pertinent environmental laws, rules and regulations

(In case of apprehension, the barangay officials were being blamed and/or criticized by their constituents)

- Hazardous naturally grown trees
- Boundary of timberland and A&D
- Mangroves within and/or adjacent to titled land/lots
- Legal sources of lumber/logs for housing purposes (Availability and/or possibility of lumbers/logs for donation to BLGU intended for construction of houses)
- Chainsaw and source of wood materials to be utilized during muslim funeral/s
- Illegal occupants/claimants within the timberland/forestland in So. Gadsan, Barangay Rio Tuba, Bataraza, Palawan
- Previous/old slash and burn kaingin areas
