SUBJECT: AMENDING CERTAIN PROVISIONS OF DENR ADMINISTRATIVE ORDER (DAO) NO. 2004-16 PRESCRIBING THE REVISED SCHEDULE OF FORESTRY ADMINISTRATIVE FEES

Pursuant to Presidential Decree No. 705, as amended, Malacañang Administrative Order No. 31 (s. 2012), and DOF-DBM-NEDA Joint Circular No. 1-2013, and in order to rationalize and update the rates of forestry fees and charges, this Order is hereby issued to prescribe the new rates of administrative fees.

The Service Fee includes payment for the allowance, food, and transportation costs incurred by the DENR personnel during the conduct of the activity.

The Community-Based Forest Management Projects are exempted from paying the administrative fees pursuant to DAO 1998-43.

The DENR shall review and update the Forestry Administrative Fees every five years, or as deemed necessary.

DENR Administrative Order (DAO) No. 2004-16, DAO No. 2004-30, DAO No. 2004-35, DAO No. 2021-26, DAO No. 2021-33, DAO No. 2022-01, DAO No. 2022-05 and all other existing administrative orders, circulars and instructions inconsistent herewith are hereby repealed or amended.

This **Order** shall take effect fifteen (15) days after its publication in a newspaper of general circulation and upon acknowledgment of receipt of a copy hereof by the Office of the National Administrative Register (ONAR) of the UP Law Center.
